The Officer-In -Charge Baghmundi Police Station

Sir,

In producing herewith arrested accused Bhubaneswar Majhi (31 Years) S/O Dilip Majhi of Gobindapur, PS- Baghmundi, Dist-Purulia along with seized articles i)205 (Two Hundred and Five) Liters of Blue Kerosene oil in 03 (Three) nos of big size plastic jerricans and 02 (two) nos of small size plastic jerricans and one measuring Chong of five (05) liters along with seizure list and arrest memo, I SI Dhirendranath Mandal of DEB Purulia do hereby lodge a written today (22.12.2018) being complaint to the effect that in persuasion a secret information directed by Dy.S.P(DEB), Purulia myself along with SI Sajal Kumar Mishra, HG 1427-Benimadhab Char and HG 1525 Falguni Kumar all of DEB Purulia arrived at Baghmundi P.S. at 11.15 hrs and noted the information vide Baghmundi P.S. GDE No- 934 Dated -22.12.2018 also submitted a requisition for rendering assistant for holding raid to work out the information. Thereafter at 11.45 hrs myself with accompanied Officers and forces arrived at Gobindapur under this P.S. and took effective entry into the bittle shop of Bhubaneswar Majhi attached to his dwelling house at Gobindapur.

On searching the bittle shop after issuing notice to the owner of the shop it could be learnt that the owner of the shop is Bhubaneswar Majhi and found there stock some blue Kerosene oil in plastic jerricans for selling in the open market. On asking he failed to produce any valid documents/License in respect of storage of such blue Kerosene oil in accordance to Essential Commodities Act. As such, as shown by the apprehended person on searching the store room nearby his bittle shop I found there is also huge quantity of blue Kerosene oil are storage inside the store room. On further asking regarding holding no of the shop as well as store room he failed to produce any by this time.

It has ascertained that will fully violating the provision of pera -4 of West Bengal Kerosene control order 1968, he committing offence punishable U/S- 7(i)(a)(ii) of Act-X 1955. On local enquiry it could also be learnt that the above accused Bhubaneswar Majhi is habituated in dealing with such clandestine storage and selling of blue Kerosene oil since long in open market in high rate in lieu of money and thereby deprived poor consumers as well as causing loss of Govt. Revenue. Hence I seized the above noted articles with proper seizure list as per weighment Chart from the possession of above noted accused person in presence of local witnesses after proper leveling and arrested the accused after maintaining all formalities regarding arrest with an information ground of arrest.

Therefore I pray kindly start a case under proper section of law against accused Bhubaneswar Majhi (31 Years) S/O Dilip Majhi of Gobindapur, PS- Baghmundi, Dist-Purulia for such offence as committed by him.
