Respected Sir,

In producing here with arrested accused person namely Buddheswar Saren (age-25 yrs) S/O Falak Saren of Vill. Darda, P.O-Kurni, P.S. Balarampur, Dist. Purulia A/P-Vill-Popo, PO-Lata, PS-Bandwan, Dist-Purulia along with seized Illicit Liquor (details of seized articles are mentioned in attached seizure list). I beg to submit that today at about 15/25 hrs during my day mobile duty I received a credible source information over mobile that one person namely Buddheswar Saren S/O Falak Saren of Vill. Darda, P.O-Kurni, P.S. Balarampur, Dist. Purulia A/P-Vill-Popo, PO-Lata, PS-Bandwan, Dist-Purulia making & selling illicit liquor in his house under Bandwan PS. Accordingly I along with force namely JC/1093 Krishnapada Runidas of Bandwan PS, Dist-Purulia & C/337, Sahara Ghosh of SAP 13<sup>th</sup> Bn, Barpara, Bankura left for Popo Village to work out the said source information vide Bandwan PS LC No. 4432/18, Dtd-16/12/18. Then, at about 16.00 hrs I reached at Popo Village and found the said person was selling illicit liquor at the court yard in front of his house under Bandwan PS. So, with the help of accompany Bava I searched thoroughly with proper decency and maintains all legal formalities and found that he is selling illicit liquor. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) E.L. Act and supply one copy to him. Then, I seized (1) Illicit liquor approx 12 (twelve) liters in a white plastic container (2) 0.3 pcs of plastic glasses (3) Cash Rs. 35/- (fifty five rupees only) as sale proceed (details in seizure list) after preparing proper seizure list duly signed by the witness and labelled.

Under the above circumstances, I therefore pray before you that a cog case may kindly be started U/S 46A(C)E.L. Act 1909 against the arrested accused person namely Buddheswar Saren S/O Falak Saren of Vill. Darda, P.O-Kurni, P.S. Balarampur, Dist. Purulia A/P-Vill-Popo, PO-Lata, PS-Bandwan, Dist-Purulia and arrange for its investigation.
