Respected Sir,

In producing here with arrested one accused person namely Anil Hembram @ Daru (31Yrs.) S/O Lt. Dasarath Hembram of Vill. Mahulboni (Dogakati More), P.S. Bandwan, Dist. Purulia along with seized illicit liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 14:05 hrs during my Spl raid duty I received a credible source information by Bandwan PS table duty officer ASI Susanta Mishra over telephone that one person namely Anil Hembram S/O Lt. Dasarath Hembram of Vill. Mahulboni (Dogakati More), P.S.-Bandwan, Dist. Purulia selling illicit liquor in his house under Bandwan PS, this refers to Bandwan P.S. GDE No.205 Dtd. 05.12.18. Accordingly, I along with force left for Mahulboni (Dogakati More), to work out the said source information Vide Bandwan PS C.C NO.4320 dt-05.12.18 Then, at about 15:45 hrs I reached at Mahulboni (Dogakati More) P.S. Bandwan Village and found the said person was selling illicit liquor at his house under Bandwan PS. So, with the help of accompany force I searched thoroughly with proper decency and found that he is selling illicit liquor. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him. Then, I seized illicit liquor approx 12 (Twelve) liters in a white plastic container (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled. Total 12 liters illicit liquor has been seized.

Under the above circumstances, I therefore pray before you that a cog case may kindly be started U/S 46A(C) B.E. Act 1909 against the arrested accused person namely- Anil Hembram @ Daru (31Yrs.) S/O Lt. Dasarath Hembram of Vill. Mahulboni (Dogakati More), P.S. Bandwan, Dist. Purulia and arrange for its investigation.
