Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act-2007, to the effect that Ajit Murmu S/O Manohar Murmu of Vill- Khariadih Sindri, P.S- Barabazar , Dist- Purulia was enjoying electricity unauthorizedly by illegal hooking from nearest LTOH line with the help of two core PVC cable and he has committed theft of electricity U/S 135(1)/A of the electricity (Amendment act-2007).

On 21.12.2018, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) SAHEB SUTRADHAR, S.A.E(E), BARABAZAR CCC, WBSEDCL
- (2) MD QASIM ANSARI, O.E., BARABAZAR CCC, WBSEDCL

At About 07:20 P.M., entered into the premises of Ajit Murmu S/O Manohar Murmu of Vill- Khariadih Sindri, P.S- Barabazar , Dist- Purulia and inspected his premises at Vill.- Khariadih Sindri, P.S Barabazar, DIST- Purulia.

During inspection, it was found that Ajit Murmu S/O Manohar Murmu of Vill- Khariadih Sindri, P.S- Barabazar, Dist.- Purulia was enjoying electricity illegally hooking from nearest LTOH line with the help of two core PVC cable in his premises at Khariadih Sindri having connected load 0.117 KVA.

From the above arrangement he was using the following arrangements:

01. 01 no electric Bulb (100 watts)
02. PVC 2 core cable (16 Mtr. App.) along with hooking device.

Out of which I seized the following articles:

01. 01 no electric Bulb (100 watts)
02. PVC 2 core cable (16 Mtr. App.) along with hooking device.

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 07.40 p.m.

The said person has committed an offence U/S 135(1)/A of electricity act 2003 subsequently electricity (Amendment) act-2007.
