Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that Nidhiram Singh Sardar S/O Lt. Nanda Singh Sardar of Vill- Tentlo, P.S- Barabazar, Dist- Purulia was enjoying electricity unauthorizedly by illegal hooking from nearest LTOH line with the help of single core PVC cable and he has committed theft of electricity U/S 135(1)/A of the electricity (Amendment act-2007).

On 21.12.2018, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSSEDCL along with

- (1) SAHEB SUTRADHAR, S.A.E(E), BARABAZAR CCC, WBSSEDCL
- (2) MD QASIM ANSARI, O.E., BARABAZAR CCC, WBSSEDCL

At About 06:00 P.M., entered into the premises of Nidhiram Singh Sardar S/O Lt. Nanda Singh Sardar of Vill- Tentlo, P.S- Barabazar, Dist- Purulia and inspected his premises at Vill- Tentlo, P.S Barabazar, DIST- Purulia.

During inspection, it was found that Nidhiram Singh Sardar S/O Lt. Nanda Singh Sardar of Vill- Tentlo, P.S- Barabazar, Dist- Purulia was enjoying electricity illegally hooking from nearest LTOH line with the help of single core PVC cable in his premises at Tentlo having connected load 0.07 KVA.

From the above arrangement he was using the following arrangements:

01. 01 no electric Bulb (60 watts)
02. PVC single core cable (24 Mtr. App.) along with hooking device.

Out of which I seized the following articles:

01. PVC single core cable (24 Mtr. App.) along with hooking device.

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 06.20 p.m.

The said person has committed an offence U/S 135(1)/A of electricity act 2003 subsequently electricity (Amendment) act-2007.
