


Haldar protested the illegal activities of the accused persons and at that time accused Sasti Haldar who had an Iron Rod in his hand without any provocation with a view to finish the life of the complainant strike on his head with that rod. By sudden attack complainant fell down and profuse bleeding was oozing out from his head. The said Sasti Haldar assaulted the complainant on different parts of his body with that iron rod by

7. That accused Gurupada Haldar assaulted Smt. Chaina Haldar with a stone on her chest and accused Smt. Lakhi Haldar also assaulted witness Shibu Haldar on his feet by stone and brick bats. Both witness Nos. 1 and 2 sustained bleeding injury.

- 8. That after making assault the accused persons left the place.
- 9. That the wife and son of the complainant took the complainant at Sindri Hospital and was treated there. Subsequently Doctor referred the complainant to Purulia Sadar Hospital for better treatment. At Purulia Sadar Hospital as per advice of the Doctor C.T. Scan and X-ray of chest and abdomen of the complainant was done. Witness No.1 and 2 were also treated at Hospital for their injury.
