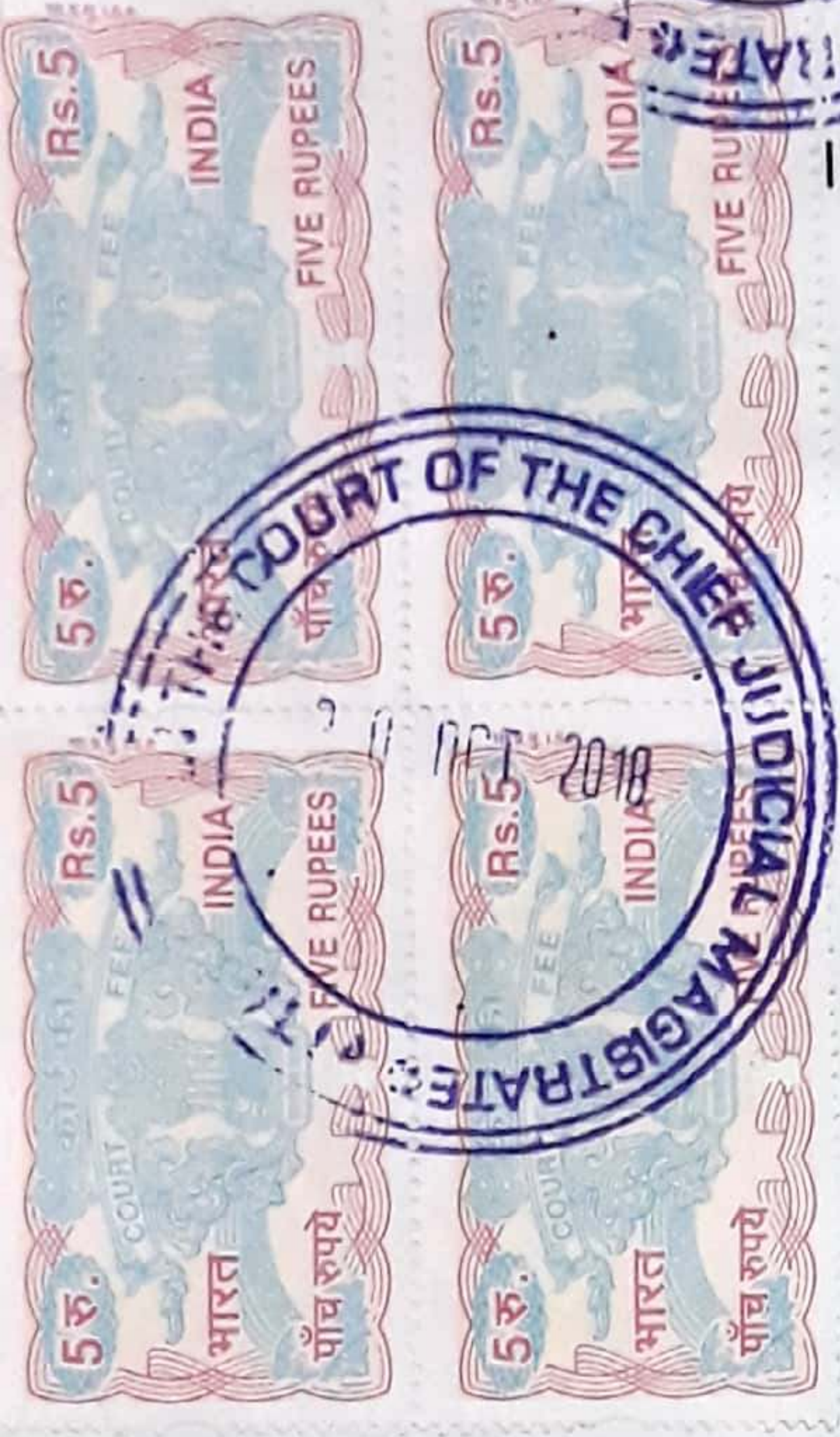

*The Complainant above named;  
Most respectfully begs to state as follows:-*

1. That the complainant and accused No.1 are two full brothers being the sons of Harisadhan Haldar.
2. That the house of Complainant and accused No.1 are situated side by side.
3. That accused No.2 is the wife of accused No.1 and accused No.3 is the son of accused No.1.
4. That on the date of occurrence i.e. on 15-09-2018 at about 10.30 a.m the accused persons by force criminally trespassed into the house and compound of the complainant being R.S Plot No.2863 of Mouza- Fatehpur Sindri.
5. That the accused persons engaged Masons and labourers and with the help of Mason and Labourers tried to fix a door by touching the house wall of the Complainant and also fixed clamp on the house wall of the complainant by striking the same with a hammer and the said accused persons intentionally dug hole by the side of the house of the complainant with an intention to damage the wall.

6. That the complainant, his wife Chaina Halдар and his son Shibu Halдар protested the illegal activities of the accused persons and at that time accused Sasti Halдар who had an Iron Rod in his hand without any provocation with a view to finish the life of the complainant strike on his head with that rod. By sudden attack complainant fell down and profuse bleeding was oozing out from his head. The said Sasti Halдар assaulted the complainant on different parts of his body with that iron rod by saying "I will finish your life".
7. That accused Gurupada Halдар assaulted Smt. Chaina Halдар with a stone on her chest and accused Smt. Lakhi Halдар also assaulted witness Shibu Halдар on his feet by stone and brick bats. Both witness Nos. 1 and 2 sustained bleeding injury.
8. That after making assault the accused persons left the place.
9. That the wife and son of the complainant took the complainant at Sindri Hospital and was treated there. Subsequently Doctor referred the complainant to Purulia Sadar Hospital for better treatment. At Purulia Sadar Hospital as per advice of the Doctor C.T. Scan and X-ray of chest and abdomen of the complainant was done. Witness No.1 and 2 were also treated at Hospital for their injury.

10. That the persons who were working on behalf of the accused namely Alip Ansary Carpenter Madhu Sutradhar witnessed the occurrence so also one Seikh Kayum of village- Sindri.

11. That information was lodged at Barabazar P.S but Police did not take any action and the accused persons are still roaming in the village and are still criminally intimidating the complainant and his family members.

12. That as Barabazar Police did not take any action so the complainant lodged complaint before S.P. Purulia on 04-10-2018.

13. That accused Sasti Haldar with a view to finish the life of the complainant assaulted him on his head.

14. That search and seizure is involved in this case and the complainant is a poor person and could not run the case in his personal capacity for which the complainant is invoking the provision under Section 156(3) of Cr.P.C.

15. That the accused persons have committed an offence Under Sections 325/324/427/447/34/506 of the I.P.C.
