Sir,

In producing herewith one accused person namely Rupesh Kumar Mahato @ Pintu (24Yr) s/o Shankar Mahato of Vill- Girgiddi, PS- Barabazar, Dist- Purulia along with seized items viz (1) one iron made box measuring 10.2" length, 7.1" width and height 3" (2) one iron made single shooter improvised fire arms (3) One iron made pipe measuring length 8.2" & circumference measuring 3.5" (4) One 7.1" iron made component having four hole (5) one 3.9" iron made plate having four hole (6) one 2.1" iron made component (7) one 1.5" iron made component (8) one 2.5" iron made component (9) one 3.7" iron made component (10) one 8.7" iron made blade (11) one iron made small spring, I SI Kabi Ranjan Singha of Barabazar P.S do hereby lodge complaint against the accused Rupesh Kumar Mahato @ Pintu to the effect that today on 03-12-18 at about 10-15 hrs received source information that one Rupesh Kumar Mahato @ Pintu of Girgiddi village is loitering at Berada more who posses improvised fire arms. After having the information I brought it to the knowledge of I/C Barabazar P.S and as per his direction I along with ASI Mukti Nath Chakrabarty, C/364 Bappaditya Pal & C/1026 Pranay Salui both of SAP 7th BN, Camp at Barabazar P.S, left P.S to work out the information vide Barabazar PS GDE No 117 dt 03-12-18. At about 11-05 hrs we arrived at Berada more and as identified by my source detained Rupesh Kumar Mahato @ Pintu. After prolonged interrogation he confessed his guilt and stated that he posses one improvised fire arms and some components of fire arms which are kept at his house in a box. To work out the information I along with force had been to the house of the accused and as shown by him recovered one box in his house inside which the above mentioned articles could be found. The accused could not be able to show any valid license issued from appropriate authority in support of possession of arms and arms component. I seized the articles under proper seizure list and labeled the same in presence of witnesses duly signed by them and took into custody. The seizure & labeling was done in between 12-05 hrs to 12-45 hrs. Then I arrested accused Rupesh Kumar Mahato @ Pintu and took into my custody. I issued memo of arrest to the arrestee. He is therefore liable for prosecution u/s 25 (1) (a)/25(1-A)/27 Arms Act 1959 for act of possession of improvised fire arms and arms component.

I therefore pray that a case may kindly be started against the accused Rupesh Kumar Mahato @ Pintu (24Yr) s/o Shankar Mahato of Vill- Girgiddi, PS- Barabazar, Dist- Purulia u/s 25 (1) (a)/25(1-A)/27 Arms Act 1959 for his act of offence.


