Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that Nayan Singh Sardar S/O Lt. Mohar Singh Sardar of Vill- Simudri, P.S- Barabazar, Dist- Purulia was enjoying electricity unauthorizedly by illegal hooking from nearest LTOH line with the help of two core PVC cable and he has committed theft of electricity U/S 135(1)/A of the electricity (Amendment act-2007).

On 10.12.2018, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) SAHEB SUTRADHAR, S.A.E(E), BARABAZAR CCC, WBSEDCL
- (2) MD QASIM ANSARI, O.E., BARABAZAR CCC, WBSEDCL

At About 06:35 P.M., entered into the premises of Nayan Singh Sardar S/O Lt. Mohar Singh Sardar of Vill- Simudri, P.S- Barabazar, Dist- Purulia and inspected his premises at Vill.- Simudri, P.S Barabazar, DIST- Purulia.

During inspection, it was found that Nayan Singh Sardar S/O Lt. Mohar Singh Sardar of Vill- Simudri, P.S- Barabazar, Dist- Purulia was enjoying electricity illegally hooking from nearest LTOH line with the help of two core PVC cable in his premises at Simudri having connected load 0.07 KVA.

From the above arrangement he was using the following arrangements:

01. 01 no electric Bulb (60 watts)
02. PVC 2 core cable (8 Mtr. App.) along with hooking device.

Out of which I seized the following articles:

01. 01 no electric Bulb (60 watts).
02. PVC 2 core cable (8 Mtr. App.) along with hooking device.

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 06.55 p.m.

The said person has committed an offence U/S 135(1)/A of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
