Sub: Complaint against Asit Saren (33 Yrs), S/O- Abinash Saren of Vill- Bardahi, PO- Jorobari PS - Boro, Dist - Purulia to start a Case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accd. person Asit Saren (33 Yrs), S/O- Abinash Saren of Vill- Bardahi, PO- Jorobari PS - Boro, Dist - Purulia with seizure of approx 30 liters illicit spirit, containing in 02 (two) Zariken (10 Litrs each) and one tube from the possession of above noted accused which was seized under proper seizure list.

I beg to submit that today (30.11.18) during mobile duty in between 19.25 hrs to 19.45 hrs on acting a secret source information I apprehended the above noted person at Bardahi at his house. and found that above noted ID Liquor which were kept in his house. On interrogation he disclosed his name and address as noted above. On demand he failed to produced any valid documents / License in r/o said illicit spirit which were kept in his house containing approx 30 ltrs illicit spirit, in 02 (two) Zariken, and one tube. Accordingly I seized the same under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith. As such he was arrested at 19.45 hrs u/s 67 B.E. Act and during arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to arrestee. Out of seized illicit liquor 500 ml taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd Asit Saren (33 Yrs), S/O- Abinash Saren of Vill- Bardahi, PO- Jorobari PS - Boro, Dist - Purulia violate section 18 (i) B.E. Act. for possession of intoxicating not obtained from a licensed vendor and in contravention and he Committed offence u/s 46 A ( C ) B.E. Act. 1909.

It may note here that during raid (1) C/1255 Ajoy Bauri, (2) C/678 Ramprasad Pain accompanied me.

Under the fact and circumstance I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Asit Saren (33 Yrs), S/O- Abinash Saren of Vill- Bardahi, PO- Jorobari PS - Boro, Dist - Purulia.
