Sub: Complaint against Gangadhar Besra (52 Yrs), S/O- Lt. Bolo Besra of Vill- Chhoto Pandra, PO- Kumari PS - Boro, Dist - Purulia to start a Case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accd. person Gangadhar Besra (52 Yrs), S/O- Lt. Bolo Besra of Vill- Chhoto Pandra, PO- Kumari PS - Boro, Dist - Purulia with seizure of approx 40 liters illicit spirit, containing in 04 (Four) Zariken (10 Litrs each) from the possession of above noted accused which was seized under proper seizure list.

I beg to submit that today (02.12.18) during mobile duty in between 18.35 hrs to 18.45 hrs on acting a secret source information I apprehended the above noted person at Chhoto Pandra at his house and found that above noted ID Liquor which were kept in his house. On interrogation he disclosed his name and address as noted above. On demand he failed to produced any valid documents / License in r/o said illicit spirit which were kept in his house containing approx 40 ltrs illicit spirit, in 04 (Four) Zariken. Accordingly I seized the same under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith. As such he was arrested at 18.45 hrs u/s 67 B.E. Act and during arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to arrestee. Out of seized illicit liquor 500 ml taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd Gangadhar Besra (52 Yrs), S/O- Lt. Bolo Besra of Vill- Chhoto Pandra, PO- Kumari PS - Boro, Dist - Purulia violate section 18 (i) B.E. Act for possession of intoxicating not obtained from a licensed vendor and in contravention and he Committed offence u/s 46 A (C) B.E. Act, 1909.

It may note here that during raid (1) C/531 Shih Shankar Mahanty, (2) C/662 Dhananjay Pandey accompanied me.

Under the fact and circumsances I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Gangadhar Besra (52 Yrs), S/O- Lt. Bolo Besra of Vill- Chhoto Pandra, PO- Kumari PS - Boro, Dist - Purulia.
