I do hereby lodge a complaint empowered by enactment of the  
electricity Act 2003 Subsequently Electricity (Amendment) Act 2008 to the  
effect that Sri Chennaram Tudu of Dham Tudu of Vill-Ukangach,  
Boro, At-Bisculia has committed theft of electricity u/s 135(1)(b) of the  
Electricity (Amendment) Act 2007.

On dated 09-12-18 at about 12.5 PM I Sri. Suresh Mandal, 2002  
Mandal, C.C., WSPDC along with

1) Binod Kumar, P.S.A. Mandal, C.C. WSPDC  
2) Neta Anshu, C.T. P.S.H. Mandal, C.C. WSPDC  
entered the premises of Sri Chennaram Tudu of Vill-Ukangach, P.S. Boro,  
At-Bisculia having Consumer No- 242159502 and inspected his premises  
and found that he was enjoying electricity unauthorisedly by bypassing of  
energy meter by cutting of incoming service cable.

During inspection theft of electricity was found i.e. he was using  
electricity unauthorisedly u/s 135(1)(b) was detected. It was also found  
that he was using the following electricity equipments

- 1) one no 300 watt bulb.
- 2) one no. 20 watt CFL lamp.

out of which we seized the following

- 1) one no 300 watt bulb along with 3(m) metre PVC wire.

The seizure list is prepared at site and the accused person

request to sign in the seizure list. The inspection team left the above premises at about 1408H on dated 09-12-18 after disconnection of his service line.

You are requested to take cognizance of the complaint in treat it as F.I.R. and action may be taken as per rule.
