Boro, Jharkhand having Consumer no- 842159502 and inspected his house
and found that he was enjoying electricity unauthorisely by bypassing
energy meter by cutting of incoming Service Cable.

During inspection theft of electricity was found to be so when
electricity unauthorisely u/s 135(1)(b) was detected. It was also found
that he was using the following electricity equipments

- 1) one no 100 watt bulb
- 2) one no 20 watt CFL lamp.

out of which we seized the following

- ① one no 100 watt bulb along with (one) metre PVC wire

The seizure list is prepared at site and the accused person

reduced to sign in the seizure list. The inspection team left the
alone premises at about 11:08 AM on dated 09-12-18 after a meeting
of his Service line.
