Nasir Ansary (60) S/O Mahabali Ansary of Vill + PO- Boro Metala; PS-Kotshila; Dist-Purulia, 5. Sk. Nijam (45) S/O Lt. Sk. Nabab of Vill- Hussendih; PS-Jhalda; Dist-Purulia, 6. Jaribul Khan (30) S/O Azad Khan of vill – Hussendih; PS-Jhalda; Dist-Purulia, along with seized articles- (i) One iron made improvised 7.65 m.m. pistol fitted with butt; body; barrel; firing pin; overall length 18 c.m. & barrel length 11 c.m., (ii) One magazine, (iii) Two rounds ammunition (KF 7.65 has been engraved at the backside of each ammunition), (iv) One BHOJALI with hand grip having length approx 50c.m., (v) One crowbar having length approx 75 c.m., (vi) One Axe having length approx 90 c.m., (vii) Two bamboo sticks having length approx 80 C.m., (viii) One bundle nylon rope, (ix) One grey coloured "TVS Star City" Motorcycle bearing Engine No. FF1LH1645271 & Chassis No. MD625FF1XH1L11544, (x) One red coloured "Hero Splendor Pro" Motorcycle bearing Regn. No. WB56L/4008; Chassis No. MBLHA10CAGHE0875\_ (last digit tampered); Engine No. not found, I beg to lodge complaint to the effect that today i.e. 21.12.18 at about 19:25 hrs I received a credible source information that a gang (approx 15/16) of dacoits are preparing themselves to commit dacoity at Kushal Polysacks (P) LTD. Jhalda being assembled in a Mango garden by the side of Purulia-Ranchi main road (SH04A) & Jhalda Kishan Mandy, vill. Baragram, P.S. Jhalda, Dist. Purulia. Accordingly, I noted the fact in G.D. and left P.S. with vehicle (WB68L/7465) to workout the said source information with S.I. Nimai Ch. Nemo, A.S.I. Sk. Habibul Hasan, A.S.I. Pankaj Kr. Gupta, C/497 Ambuj Mondal, C/380 Ajaykrishna Roy, C/571 Md. Hasib Khan, NVF855 Pradip Singh Mura, NVF0039 Lalit Kishor Mahato & HG1681 Manmatha Kumar after obtaining kind permission from I/C Jhalda P.S. This refers to Jhalda P.S. GDE No. 774 Dtd: 21.12.18.

Then, I along with accompanied officers and force reached near the Mango garden at about 20:05 hrs and stopped the vehicle by the side of Purulia-Ranchi main road (SH04A) keeping distance approx 50 meters from said Mango garden. After that, we started to proceed on foot and when we reached near the Mango garden, found 15/16 persons sitting inside the garden (by the side of Purulia-Ranchi main road & Jhalda Kishan Mandy) whispering each others. Their voice was clearly audible to us due to night & the place was silent zone. They were planning to commit dacoity at "Kushal Polysacks (P) LTD. Jhalda". After confirmation, we cordoned the area secretly and loudly disclose our identity with a direction to surrender before us. But, all of them tried to run away seeing the police party. However, we manage to apprehend 06 (six) out of them after a hot chase. Accordingly, I interrogate them thoroughly where they disclosed their identity as-

2. Nani Gopal Kumar (19) S/O Sridhar Kumar of vill+PO- Majhidih; PS-Kotshila; Dist-Purulia.
3. Dinesh Paramanik (25) S/O Madhusudan Paramanik of vill+PO- Majhidih; PS-Kotshila; Dist-Purulia.
4. Nasir Ansary (60) S/O Mahabali Ansary of Vill + PO- Boro Metala; PS-Kotshila; Dist-Purulia.
5. Sk. Nijam (45) S/O Lt. Sk. Nabab of Vill- Hussendih; PS-Jhalda; Dist-Purulia.

and also confessed that they along with-

- (i) Manoranjan Kumar @ Malahar S/O Bhogtu Kumar of vill. Beldih(Tola Jaratanr), P.S. Kotshila; Dist. Purulia.

(ii) Aswini Kumar S/O Darik Kumar of vill. Beldih(Tola Jaratanr), P.S. Kotshila; Dist. Purulia.  
(iii) Dharma Kumar S/O Bhagbat Kumar of vill. Belyadih, P.S. Kotshila; Dist. Purulia.  
(iv) Bhogtu Gope of vill. Sikhartanr, P.S. Kotshila, Dist. Purulia.  
(v) Sk. Kalu S/O Sk. Abdul of vill. Kantadih; P.S. Jhalda; Dist. Purulia and 04 (four) others (most probably criminals of Jharkhand side) being armed with deadly weapons were gathered to prepare themselves for committing dacoity at "Kushal Polysacks (P) LTD. Jhalda". Accordingly, I arrest them after prepared proper arrest memo. On search, we recovered and seized the following weapons after preparing proper seizure list & Labels duly signed by the witnesses –  
(i) One iron made improvised 7.65 m.m. Pistol fitted with butt; body; barrel; firing pin; overall length 18 c.m. & barrel length 11 c.m. which recovered from the exclusive possession of accused Barun Kuiry (kept conceal at the backside os waist position).  
(ii) One magazine (recovered & seized after unloaded from seized Pistol).  
(iii) Two rounds ammunition, KF 7.65 has been engraved at the backside of each ammunition (recovered & seized after unloaded from seized Pistol).  
(iv) One BHOJALI with hand grip having length approx 50c.m. (recovered & seized from the possession of accused Nani Gopal Kumar).  
(v) One crowbar having length approx 75 c.m. (recovered & seized from the possession of accused Dinesh Paramanik).  
(vi) One Axe having length approx 90 c.m. (recovered & seized from the possession of accused Nasir Ansary).  
(vii) Two bamboo sticks having length approx 80 C.m. (recovered & seized from the possession of accused Sk. Nijam & Jaribul Khan).  
(viii) One bundle nylon rope (seized from the place of assemble).  
(ix) One Grey coloured "TVS Star City" Motorcycle bearing Engine No. FF1LH1645271 & Chassis No. MD625FF1XH1L11544 (seized from the place of assemble).  
(x) One Red coloured "Hero Splendor Pro" Motorcycle bearing Regn. No. WB56L/4008; Chassis No. MBLHA10CAGHE0875\_ (last digit tampered); Engine No. not found (seized from the place of assemble).  
I like to note here that due to odd hours of night no public witnesses were available at that time.

Hence, I do here by lodged suomoto complaint against the following accused persons namely –
