In producing here with the arrested accused persons namely (i) Budhu Gorain (40) S/O Lt. Sir, Pustam Gorain (ii) Amar Nath Sing Mura (48) S/O Lt. Premu Sing Mura both are of Vill- + PO- Pat Jhalda, PS- Jhalda, Dist. Purulia along with seized 36 Country sprit bottles (DIL KHUSH, each bottle contain 600 ml) and approx 10(Ten) Ltrs. l.D. liquor (Mahula) in a plastic Jerkin from their possession. I do hereby lodged this written complain to the effect that on-06/12/2018 at about 18:05 hrs, I received a telephonic source information that some persons are selling Country sprit bottles and I.D. liquor (Mahula) from their dwelling house at Pat Jhalda Village. Accordingly, 1 informed the matter to I/C Jhalda P.S and as per his direction myself along with SI- Nimai Ch. Nemo, ASI- Sk. Habibul Hasan, C/696- Gorapada Pal, C/571- Md. Hasid Khan, C/1376- Tapan Das left for Pat Jhalda village to work out the said source information. This refers to Jhalda P.S. GDE No- 239/18 Dt-06/12/18.

Then, we reached at Pat Jhalda Village at about 18:30 Hours and held raid in the house of Budhu Gorain S/O Lt. Pustam Gorain and found that the accused person is selling Country sprit bottles (DIL KHUSH) and I.D. liquor (Mahula) from his house jointly with accused Amar Nath Sing Mura S/O Lt. Premu Sing Mura both are of same village. Accordingly, I asked him to produce valid license or relevant papers in support of selling liquors, but they failed to produce however sufficient time was given.

Then, I along with my accompany force searched and seized 36 Country sprit bottles [FAL KHUSH, each bottle contain 600 ml) and approx 10(Ten) Ltrs. l.D. liquor (Mahula) in a plastic Jerkin under proper seizure list duly signed by the witnesses as well as accused persons with proper label. I search for local witnesses but none was available there. After that, I interrogate them thoroughly where they confessed that they were selling liquors since long illegally.

Accordingly, I arrested both of them namely- (i) Budhu Gorain (40) S/O Lt. Pustam Gorain, (ii) Amar Nath Sing Mura (48) S/O Lt. Premu Sing Mura both are of Vill- + PO- Pat Jhalda, PS- Jhalda, Dist. Purulia having maintained all formalities after issuing proper arrest memo. So, they committed offence which punishable U/S - 46 (A) (c) of B.E. Act. 1909.

On return to P.S. put the arrested accused persons into the P.S. Lock UP after maintaining all formalities and handed over the seized articles to Malkhana Officer.

Hence, I do here by submitted written complaint to you to start a case against arrested accused (i) Budhu Gorain (40) S/O Lt. Pustam Gorain and (ii) Amar Nath Sing Mura (48) S/O Lt. Premu Sing Mura both of Vill- + PO- Pat Jhalda, PS- Jhalda, Dist. Purulia under proper section of law.
