Sir,

In producing herewith one arrested accused person namely Khedan Sahis (35) S/o-Khandu Sahis of Vill-Adrakuri, PS-Chandankiyari, Dist-Bokaro (Jharkhand), under arrest along with seized articles as per seizer list i.e. approx 20 Liters (twenty) Illicit Distilled Liquor in 01 (one) black colour Plastic Jerrycan under proper seizure with label.

I SI Sunil Kumar Banerjee of Joypur PS hereby lodged a written complaint against the above noted accused person to the effect that today (03/12/2018) at about 15:15 hrs in course my special duty I received a credible source information that one person namely Khedan Sahis (35) S/o-Khandu Sahis of Vill-Adrakuri, PS-Chandankiyari, Dist-Bokaro (Jharkhand) is selling ID liquor at Bartard Haat area under Joypur PS. On receipt such information I immediately inform the matter to IC Joypur PS and as per his kind direction myself along with C/-120 Sandip Kumar RJC/-1397 Shyamal Hembram (This refers to Joypur PS CC No. 3607 dated 03/12/2018) left to work out the information from Gunja More. At 15:25 hrs we reached at Bartard Haat and found that one person selling ID liquor at Bartard Haat west side of the Purulia Bokaro Road (NH-32) as denoted by my source. On seeing police party some persons who were assemble there for consume liquor, immediately fled away from the spot but we managed to apprehended the above noted accused person and found one black colour Jerrycan which was loaded approx 20 liters Illicit Distilled Liquor was laying on the spot . On interrogation the above noted accused person disclosed his name and address as noted above and also to stated that he selling Id liquor in this Haat area illegally to people who were coming from different places in this Haat. So I asked him about the license / authority for selling of Id liquor, but he failed to produce any documents in respect of said Liquor. So, in between 15:45 hrs to 16:05 hrs I seized the above noted articles under proper seizure list as produce by accused person duly singed by him and other available witnesses in which I have taken one bottle of ID liquor i.e. one 300 ML as sample file with label and finding no any other alternative way I arrested him from Bartard Haat at 16:10 hrs after observing all the formalities as per law and narrating him the ground of arrest and issuing arrest memo as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Khedan Sahis (35) S/o-Khandu Sahis of Vill-Adrakuri, PS-Chandankiyari, Dist-Bokaro (Jharkhand)u/s-46A (c) of the Bengal Excise Act 1909.
