Sir,

In producing here with the accused person namely Sankar Bouri (46) S/o Madan Bouri of Narayanpur tola Bartard, PS-Pindrajora, Dist-Bokaro, State-Jharkhand A/p in the house of one Suresh Bouri S/o Late Sripati Bouri of Kumardih, PS-Chandankeyari, Dist-Bokaro, State-Jharkhand brought under arrest along with seized articles as per seizure list i.e. one improvised country made fire arm (Iron made) length in total 10 inches having Iron butt, body, barrel, trigger, firing pin etc and 03 (three) rounds live ammunition, I, SI Jayanta Kumar Chakraborty of Joypur PS do hereby lodged a written complaint against the above noted accused person to the effect that on 03/12/2018 at 14:35 hrs while myself along with C/45 Samir Kumar Mahato, C/237 Gopi Nath Roy, C/05 Biswajit Mahatpatra, (Joypur PS GDE No 113 dated 03/12/2018 & CC No.3599/18) & CVF-52 Bibek Mahato, CVF-122- Janmejyoy Sahis all of Joypur PS were engaged in Naka checking duty at Kathatard strategic point at Jharkhand Border on Purulia – Bokaro Pitch Road (NH-32) and found the above noted person was coming from Pindrajora Side via NH32 towards Kathaltard on foot and on seeing the Naka Checking party he tried to run away. Immediately the checking team apprehended him at Kathaltard Naka Checking Point. I asked him why he tried to flee away. Then he made incoherent statement. I searched him on the spot and found one improvised country made fire arm loaded with one round live ammunition was kept in his left side of the waist concealed under the shirt. On care full searched another 02 (two) live ammunition were recovered from his left side pocket of wearing full pant (Ash Colour). On demand of papers he failed to produce any papers / documents in support of carrying / possessing such fire arm and ammunition. On interrogation he disclosed his identity as noted above and made incoherent statement in respect of his presence at that place and also the purpose of possessing said fire arm and ammunition. So, it is reasonable to believe he choose the said place pre-plainly to commit any grievous offence at Bartard Hat as today is the day of Hat at Bartard on Purulia-Bokaro Road. So finding no any other alternative way and after observing all the formalities I seized the said fire arm and ammunition & his wearing full pant under proper seizure list in presence of witnesses as well as accused person and make over one copy of the seizure list to him and he put his signature as token of acknowledgement and also labeled the same by me. I also supplied him a trouser for his wearing as his pant has been seized in this case. I tried my label best to singe the public witnesses but none is willing to put their signature on the seizure list as the accused is a veteran criminal of Pindrajora PS area. So I unable to put signature any public witnesses on the seizure list. Hence I arrested him issuing memo of arrest as he has violated the provision of Arms Act, 1959.

During interrogation he also confessed that previously he was arrested in a Dacoity case by Pindrajora Police, Dist-Bokara, Jharkhand in the year of 1995 and also was involved in many crime in Jharkhand State.

I therefore pray that a specific case may kindly be started against the accused person namely Sankar Bouri (46) S/o Madan Bouri of Narayanpur tola Bartard, PS-Pindrajora, Dist-Bokaro, State-Jharkhand A/p in the house of one Suresh Bouri S/o Late Sripati Bouri of Kumardih, PS-Chandankeyari, Dist-Bokaro, State-Jharkhand, under proper section of law and arrange its regular investigation.
