In producing herewith one arrested accused person namely Biswanath Gope @ Bisu (24) S/o-Jhabu Gope of Vill-Karkara Gope Para, PS-Joypur, Dist-Purulia (WB), under arrest along with seized articles as per seizer list i.e. 39 (Thirty Nine) pieces of plastic lid sealed Foreign Liquor printed as "ROYAL STAG PREMIER WHISKY" 180 ML each and also noted that "FOR SALE IN JHARKHAND ONLY" and 23 (Twenty Three) pieces of plastic lid sealed Foreign Liquor printed as "IMPERIAL BLUE FINEST GRAIN WHISKY" 180 ML in each bottle and also noted that "FOR SALE IN JHARKHAND ONLY" under proper seizure with label.

I SI Nitish Goswami, OC Baglata IC under of Joypur PS hereby lodged a written complaint against the above noted accused person to the effect that today (05/12/2018) at about 16:45 hrs in course my special raid duty I received a credible source information that one person namely Bisu Gope of Karkara Gope Para is selling liquor from his tea stall at his village under Joypur PS. On receipt such information I immediately inform the matter to IC Joypur PS and as per his kind direction myself along with C/-991 Aditya Seth & C/530 Sankar Mahato (This refers to Baglata IC under Joypur PS GDE No-118 Dated- 05/12/18 & CC No. 1965 dated 05/12/2018) left to work out the information from Ropo village. At 17:15 hrs we reached at Karakar Gope Para and found that one person is selling liquor in his shop as shown by my source. On seeing police party some persons who were assemble there for consume liquor, immediately fled away from the spot but we managed to apprehended the seller and on searched his shop found 02 (two) Cartoon Boxes which were loaded with the Foreign Liquor as noted above concealed under a Khatia at his shop. On interrogation the above noted person disclosed his name and address as noted above and also to stated that he is selling liquor from his tea stall illegally to the local people. So, I asked him about the license / authority for selling of said liquor, but he failed to produce any documents in respect of said Liquor. So he violated the provision of Bengal Excise Act, 1909. As such I seized the above noted articles under proper seizure list as produce by accused person duly singed by him and other available witnesses in between 17:25 hrs to 17:55 hrs, in which I have taken two bottle of liquor from each cartoon as sample (ROYAL STAG PREMIER WHISKY" 180 ML & IMPERIAL BLUE FINEST GRAIN WHISKY" 180 ML) with label and finding no any other alternative way I arrested him from his shop at 18:05 hrs after observing all the formalities as per law and narrating him the ground of arrest and issuing arrest memo as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909. The worth of seized articles Rs. 8220/-.

I therefore pray that a specific Case may kindly be started against the accused person namely Biswanath Gope @ Bisu (24) S/o-Jhabu Gope of Vill-Karkara Gope Para, PS-Joypur, Dist-Purulia (WB) u/s-46A (c) of the Bengal Excise Act 1909.
