Ismail Ansary of village-Bartard P.S- Joypur, Dist- Purulia(Con\_Id-200701609, Meter No-G1190520) has committed theft of electricity U/S 135(1) (b) of electricity act 2003 subsequently amendment act 2007.

On 19.12.2018 at about 2.30 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Ganesh Mahato, Gr1 TSH, Joypur CCC, 02. Shibaram Mahato, HG.TSH, Joypur CCC entered the premises of Nasir Ansary, S/O-Lt. Ismail Ansary of village-Bartard P.S- Joypur, Dist- Purulia(Con\_Id-200701609, Meter No-G1190520) and found Nasir Ansary, S/O-Lt. Ismail Ansary was enjoying electricity unauthorizedly drawing power from the incoming service line of WBSEDCL through CU cable Blue colour by means meter bypassing to his house premises and connected load found 0.2 KW. As Nasir Ansary, S/O-Lt. Ismail Ansary committed theft of electric power. So, I seized the following articles after preparing the seizer list in presence of 01.Ganesh Mahato, Gr1 TSH, Joypur CCC, 02. Shibaram Mahato, HG.TSH Joypur CCC. The inspection team left the premises at 2.50 P.M.
