On 19.12.2018 at about 03.35 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Ganesh Mahato, Gr1 TSH, Joypur CCC, 02.Shibaram Mahato, HG.TSH, Joypur CCC entered the premises of Samsundar Kumar, s/o-Murali Kumar of village-Mirdih P.S- Joypur, Dist- Purulia and found Samsundar Kumar, s/o-Murali Kumar was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through CU cable blue Colour by means direct hooking to his house premises and connected load found 0.15 KW. As Samsundar Kumar, s/o-Murali Kumar committed theft of electric power. So, I seized the following articles after preparing the seizer list in presence of 01.Ganesh Mahato, Gr1 TSH, Joypur CCC, 02.Shibaram Mahato, HG.TSH Joypur CCC. The inspection team left the premises at 04.00 P.M.
