I, SI Mithun Kr Sar O.C Kashipur P.S do hereby lodge this FIR as suomotu against arrested accd persons (1) Sk Manu (31) S/o Sk Gulshan of Vill- Hutmura, PS- Purulia(M), Dist- Purulia and 2) Sk Mustakim (59) S/O Lt Sk Bahadur of Vill- Tatari, , PS- Purulia(M), Dist- Purulia to the effect that today(19.12.18) during Naka checking duty at around 20.25 hrs myself along with force on Kashipur - Ladhurka road at Gamarkuri More under Kashipur PS, found one Pick UP Van was running from Ladhurka side and was headed to Kashipur side with excessive speed and accordingly we intercepted the vehicle and found one person was on the driver's seat and another was beside him and there was none except them. In their presence I found that the vehicle bearing Rgn No. WB55A/1419 (Tata Ace Pick UP) was loaded with total four cows of different size (White Colour). On asked they revealed their identity as noted above (SL no 1 is the driver and SI No 2 is his assistant) but their identities could not be verified as they could not produce any document in respect of their address and age. On demand they could not produce any paper in respect of the vehicle as well as the four Cows, and about the procurement of the cattle as well as the vehicle, they stated incoherently and from their statements there is every ground to believe that they have procured the vehicle and the cattle in any fraudulent means or by means of theft and was trying to conceal those and they are habituated offender in such offense. Moreover they were carrying those cattle in the vehicle in such a manner that those cattle were huddling together for the want of space. The above noted accd persons treated the cattle in such a vehicle which does not those to unnecessary pain as they loaded those in such a manner so as subject and the vehicle bearing RGN No WB55A/1419 (Tata Ace Pick UP) from 20.45 hrs to 21.15 hrs from the possessions of the above noted accd persons under proper seizure list where the description of each cow is mentioned and after seizure I arrested them. It is to be noted that the place being remote no public witness could be made available and hence my accompanying police forces stood witnesses. After that I brought the arrested accd persons, seized vehicle and the seized cows to PS.

Therefore I started a specific case vide Kashipur P.S Case No 104/18 dt 19.12.18 U/S- 379/411/413/414 IPC and U/S- 11(1)(d)(e)(f) of the prevention of cruelty to Animal Act 1960 against the arrested accused persons (1) Sk Manu (31) S/o Sk Gulshan of Vill- Hutmura, PS- Purulia(M), Dist- Purulia and 2) Sk Mustakim (59) S/O Lt Sk Bahadur of Vill- Tatari, , PS- Purulia(M), Dist- Purulia.
