Sir,

I SI Goutam Kr. Mahata of Kashipur PS do hereby lodged this complaint against Dilip Ghosh, President of State BJP, Mukul Roy, member of BJP central committee, Bidyasagar Chakraborty, President of BJP Purulia district, Sayantan Basu, leaders of BJP and 500/600 others BJP supporters to the effect that as per your direction myself along with force went in front of Kashipur Michael Madhusudan College under Kashipur P.S and found that today i.e. on 23.12.18 from 14.30 hrs to 16.30 hrs under the leadership of above noted accused persons local political leaders and about 500/600 supporters of BJP assembled in a field near Kashipur Michael Madhusudan college having plot no 790 under Mouza Rangiladih under Kashipur PS and held a public meeting and a procession was organized at Kashipur bazaar area without taking any permission from concern authority. I warned them to stop that meeting as it is going on without taking any permission of the competent authority and also without consent of the land owner but they did not paid any attention to me. Rather they continued that meeting. Moreover they gave threat of injury to Police personnel and also used slag languages during delivering their speeches. During meeting Mike, sound boxes are also used without taking any permission from concern authority.

Therefore I pray before you that a specific case may kindly be started against Dilip Ghosh, President of State BJP, Mukul Roy, member of BJP central committee, Bidyasagar Chakraborty, President of BJP Purulia district, Sayantan Basu, leaders of BJP and 500/600 others BJP supporters under proper section of law.
