Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Kartick Bouri S/O-LT. Nagen Bouri , Vill-Agrabaid P.O- Monihara Dist-PURULIA has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 24.12.2018 I received a secret complain over telephone that Sri Kartick Bouri S/O-LT. Nagen Bouri , Vill-Agrabaid P.O- Monihara Dist -PURULIA consuming electricity by means of hooking from nearest It line of WBSEDCL.

On the basis of said complaint at about 11.50am. I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

- 1) Sri Dipak Kr. Bhowmik, SAE, Kashipur CCC
- 2) Sri Debraj Roy, Office Executive, Kashipur CCC.

- Entered the firm of Sri Kartick Bouri in presence of villagers During inspection it has been found that he is consuming electricity dishonestly by means of hooking for his premises .Total Load found approx 0.2 KW ( Bulb-2 nos)

Then we disconnect his hooking line and seized the following articles.

- 1) PVC wire ,mixed color with hooking device—7 mt. (approx)

After preparation of proper seizure list The seizure list are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 12.20 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
