On the basis of said complaint at about 01.20 pm. I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

1)Sri Dipak Kr. Bhowmik, SAE,Kashipur CCC

2) Sri Debraj Roy, Office Executive, Kashipur CCC.

Entered the firm of Sri Biswanath Mondal in presence of villagers During inspection it has been found that he is consuming electricity dishonestly by means of hooking for his water pump set for agriculture purpose(vegetables).Total Load found approx 0.4 KW ( Pump Set-1 no)

Then we disconnect his hooking line and seized the following articles.

1)PVC wire ,mixed color with hooking device—8 mt. (approx)

After preparation of proper seizure list The seizure list are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 01.45 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
