

In producing herewith the arrested accd persons namely (1) Arfet Ali Dalal (37 yrs) S/O Badiruddin Dalal of vill Punisole (Paschim Dakshin Para), P.S Onda Dist Bankura and (2) Arbaz Sekh (27 yrs) S/O Lt Samsur Sekh of vill Chanda, P.S Jamuria Dist Paschim Barddhaman along with original seizure list and seized articles i.e. (1) Hero Super Splendor Motor Cycle Black and Grey colour bearing Regt No WB 68R/6936 (2) One Axe measuring approx height 6 1/2 Inches, Butt made with bamboo height 30 Inches and sharp edge 2.3 Inches and (3) 1 (One) Dagger measuring approx 18 1/2 Inches with butt iron made 4 inches, breathe 1 1/2 inches (4) Two Torch Light. I beg to submit that on 24.12.18 at 21.15 hrs received a credible source information that some persons namely (1) Arfet Ali Dalal (37 yrs) S/O Badiruddin Dalal of vill Punisole (Paschim Dakshin Para), P.S Onda Dist Bankura and (2) Arbaz Sekh (27 yrs) S/O Lt Samsur Sekh of vill Chanda, P.S Jamuria Dist Paschim Barddhaman (3) Mustafa Ansari S/O Lt Rustam Ansari of vill Kuldi, P.S Kashipur Dist Purulia (4) Asamul Ansari @ Chand S/O Usman Ansari of vill Metyal Sahar, P.S Adra, Dist Purulia (5) Saddam Ansari S/O Saruddin Ansari of do (6) Inul Ansari of do and 2/3 others are assembled and preparing to commit dacoity near Garchar village under Kashipur P.S area. I diarised the fact vide Kashipur P.S GDE No 897 dtd 24.12.18 and as per your direction myself along with C/1233 Laxmi Kanta Mahato, C/657 Jaharlal Murmu, C/413 Bijoy Goswami, C/1192 Raicharan Maji and NVF/560 Tapan Saren all of Kashipur P.S wearing full uniform left for Garchar village under Kashipur P.S to work out the information. On reaching at Garchar village at 21.35 hrs we stopped our vehicle at a distance place as guide by the source and proceeded towards the anticipatory place and we noticed that some persons were sitting/assembled surrounding each other and one motor cycle stand by the side. We silently proceeded nearer to them and heard that they were planning in between each and other for committing dacoity in a petrol pump at Kashipur Bankura road near Garchar village under Kashipur P.S. Accordingly we cordoned them and I shouted in a loud voice disclosing our identity and asked them to surrendered before us. In the mean time, the assembled miscreants tried to flee away from the spot but we managed to apprehend above noted 2 miscreants and others 6/7 persons were managed to escape despite hot chase which was seen by dragon light those were with us. On being asked they failed to give any satisfactory reply in respect of their presence at there. In course of through interrogation they disclosed their particulars as noted above. In course of searching individually I found one Axe measuring approx height 6 1/2 Inches, Butt made with bamboo height 30 Inches and sharp edge 2.3 Inches from the possession of accd Arfet Ali Dalal and a torch light from his waist, 1 (One) Dagger measuring approx 18 1/2 Inches with butt iron made 4 inches, breathe 1 1/2 inches with one torch light from the waist of accd Arbaz Sekh. One Hero Super Splendor Motor Cycle Black and Grey colour bearing Regt No WB 68R/6936 stand nearby them. On being asked in respect of possession the offending articles they failed to give any satisfactory accounts in respect of the offending articles. On interrogation they confessed that they were assembled to commit dacoity at the night at nearby petrol pump under Kashipur P.S. Accordingly I seized and lebeled the above noted articles and also seized the same motor cycle under proper seizure list duly signed by the accd persons and Police personnel as there is no public were present at that time. Hence I arrested them and communicated the reason of arrest and issued memo of arrest. Hence I would pray before you that a specific case U/S 399/402 IPC may kindly be started against the above noted accd persons and others 2/3 co accd persons and arranged for its investigation.
