Sir, This is to inform you that Nityananda Goswami, son of late Rasomay Goswami, from Chhatrangamati village under Kashipur police station, Purulia. He is purchasing paddy at less than Minimum Support Price (MSP) from the poor farmers and using other farmers' bank account to sell his own paddy to gain more profit. He is selling more than 90 quintal paddy and cheating others. He is spoiling the true purpose of government of procurement. Whereas permissible limit of government to sell paddy is only 90 quintal. But he crosses this limit using other people's bank A/c. He has sold large quantity of paddy at Kashipur CPC for last two months.
