Sir,

I ASI Jayanta Chakraborty of Kashipur PS do hereby lodged this complaint against Jayanta Goswami, President of BJP Kashipur Mandal - I, ZP 29, Sanjib Mishra @ Tony S/O Prakash Mishra of vill Arrah, P.S Adra Dist Purulia, the owner of sound system and 500/600 others BJP supporters to the effect that on 23.12.18 at 14.15 hrs duty officer of Kashipur P.S received a telephonic information that above noted accd persons organized a meeting in a field near Kashipur Michael Madhusudan College. This matter has been diarised vide Kashipur P.S GDE No 855 dtd 23.12.18. As per your order myself along with force went in front of Kashipur Michael Madhusudan College under Kashipur P.S and found above noted accd persons organized a meeting with sound system in front of Kashipur Michael Madhusudan College having plot no 790 under Mouza Rangiladih. On 22.12.18 A.D.M (Gen), Purulia issued a notice vide Memo No 41/C Dtd 22.12.18 to Jayanta Goswami that he is going to conduct a political meeting at Kashipur Michael Madhusudan College without taking permission of the competent authority and also without consent of the land owner and he has been directed to stop to do so. I warned them to stop that meeting as it is going on without taking any permission from competent authority but they did not paid any attention to me. Rather they continued that meeting. Moreover they gave threat of injury to Police personnel during delivering their speeches. During meeting Mike, sound boxes are also used without taking any permission from concern authority.

Therefore I pray before you that a specific case may kindly be started against Jayanta Goswami, President of BJP Kashipur Mandal - I, ZP 29, Sanjib Mishra @ Tony S/O Prakash Mishra of vill Arrah, P.S Adra Dist Purulia, the owner of sound system and 500/600 others BJP supporters under proper section of law.
