Shibu Kumar of Vill- Barabandya P.S - Jyapur Dist- Purulia, At present SI of Kenda police station Dist- Purulia do hereby lodge this FIR as suomotu against arrested a/cd persons 1) Laladhar Sing S/O Lt. Bhaktu Singh of village Gurpa P.S kenda Dist- Purulia 2) Swapan Das S/O Lt. Fakir Das of village- Matkumdi P.S Purulia(M) Dist- Purulia 3) Santosh Rajak S/O Lt. Khanda Rajak of village Koldhari (Keshya) P.S Kenda Dist- Purulia 4) Jagannath Mahato S/O Santosh Mahato of village Keshya P.S Kenda Dist- Purulia 5) Amal Mahato S/O Lt. I informed the fact to O/C and noted in GD then myself accompanied with ASI Surendranath Soren, C-106 Maheswar Majhi, C-1492 Dilip Gorai and C-897 Dilip Gosh, vide Kenda P.S CC No-1888/18 Dtd- 24.12.18, and night mobile officers and force with the Govt. Vehicle bearing regd. No- WB-26C-7292

Left P.S. to work out the source information after 30 mins we reached 100 meters back from Gurpa more and standing our vehicle there. Then we proceeded towards Gurpa more on feet. When we reached in front of "Suraj Mistannya Bhandar" heard whispering of some persons from the back side of the said sweet shop. we noticed that the door and windows of the house that behind the sweet shop were lock from inside and whispering came out from that house. we also noticed 05 (Five) Motor cycles having regd. No- (1) WB56E-6022 (2) WB 56G-4076 (3) WB56J-8212 (4) WB56G-5146 (5) JH-09AF 5529, were standing in front of the said house. we ghaurud the possible escaping places by studying our force. Then I knocked at the door and pretending myself as gambler came from outside and want to play with them. After few mins some one came to the door and opened it. we forcibly entered in to the house and noticed that 11 (Eleven) persons were sitting in a round manner on the floor covered with one Yellow Pulithin carpet surrounded by 05 white carpet and playing among them selves with cards for their wrong full gain / loss. Accordingly I arrested them one by one. Prepared memo of arrested on spot. During arrest I observed all the guide lines of apex court, seized 1. One Yellow carpet length in to breadth 19X10 2) Playing cards 06 packets containing 52 pcs. each 3) 05 Pcs. of white colour plastic bags style as grower 4) One empty bottle 3X nam - 375 ml. 5) One Match box 6) 06 packet of bin, one khairi packet, one packet Gaska. 7) Total Board money Rs. 47890/- (Rupees Forty Seven Thousand Eight hundred Ninety only) in which (Rs.- 2000x3 + Rs. 500 X 60 + Rs - 200 X 6 + Rs.- 100 X 96 + Rs.- 50X15 + Rs- 20X 06 + Rs.-10X17) under proper seizure list as alamati. On interrogation all the arrested persons confessed their guilt and informed me also that they came to this house by the said motor cycles as noted above and standing these in front of the door of the house. One Hafadhar Sing @ Tiya S/O Lt. Bhaktu Singh of village Gurpa P.S Kenda Dist- Purulia voluntarily confessed that he is the owner of the said house and arranged for /or used in gambling purpose the whole night of a day where as he sold sweets, paddy during day time and after sunset the back side room of the house used for gambling. Accordingly I also seized the said 05 motor cycles having regd. No- (1) WR60E-6022 (2) WB 56G-4076 (3) W150J-

8212 (1) WB58G-348 (2) JH-65AE-3319 under proper seizure list as above of the case. During seizure no public witnesses were noticed except Police as such odd hours of night. Moreover there is no houses noticed around one kilometre of the said house only one Hanuman Temple was seen just 25 ft. Away from the said house. Then I came to P.S along with all the arrested persons and seized articles.

The above noted accd persons were committing offences u/s W.B.G & PC Act-1957 as they admitted that they were playing with cards for their wrong ful gain / loss purpose inside the house of one Haladhar Singh & Tiya S/O Lt. Bhanu Singh of village Gurpa P.S Kenda Dist- Purulia.

I therefore requesting you to treat this complain as FIR and kindly start a case against the above named arrested persons under proper section of law and obliged.
