I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Brijeshpati Mudi S/O Khandu Mudi of Village- NarSingdih, P.O- Rajnarayan P.S.- Kenda, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 05-12-18 at about 6:30 P.M, Sri Swarn Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Sri Brijeshpati Mudi, S/O Khandu Mudi of Village- NarSingdih, P.O- Rajnarayan, P.S.- Kenda, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity unlawfully by direct tapping from overhead LTOR line

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected, it was also found that he/she was using the following electrical equipments -

out of which we seized the following -
