Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Bhikashati Mudi S/O Khandu Mudi of Village- Nar singhdih, P.O- Pagnanagar P.S.- Kenda, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 05-12-18 at about 6.30 P.M I, Sri Guramp Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Sri Bhikashati Mudi, S/O- Khandu Mudi of Village- Nar singhdih, P.O- Pagnanagar, P.S.- Kenda, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity unauthorisly by directt taking from woode CTOP line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -
