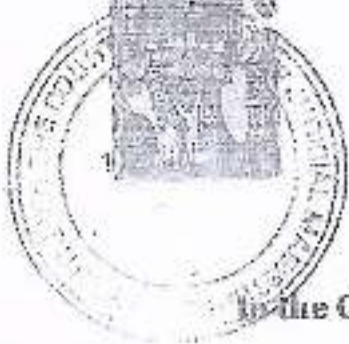

Most respectfully begs to state:

1. That the Complainant is the legally married wife of the Accused Person No.1 and the Accused Person No. 2 & 3 are the parent's-in-law and the Accused Person No.4 is the uncle-in-law of the Complainant. The Accused Person No. 5 is the sister-in-law of the Complainant and the Accused Person No. 6 & 7 are the sons of Accused No.5 who are living with their mother at Dharitanr.
2. That the marriage of the Complainant was solemnized about 12 years ago with the Accused Person No.1 as per Hindu rites and customs prevailing in their society at the paternal house of the Complainant at Village-Velaidi, PS-Arsha, District-Purulia. At the time of marriage the father of the Complainant gave Rs.10000/- in cash and ornaments and also furniture and utensils as per demand of the Accused Person Nos.1, 2 & 3.
3. That after the marriage the Complainant went to her matrimonial home at Village-Dharitanr within PS-Kotshila, District-Purulia and residing therein.
4. That since after the marriage the Accused Person Nos.1, 2 & 3 started to ill-behave and ill-treat the Complainant. The husband of the Complainant and on started to torture the Complainant both mentally and physically and he also instigated others to ill-treat the Complainant. The Accused person No.5 is residing with her father and she along with her two sons also illtreat and torture the Complainant. The Accused No.6 & 7 did not give respect to the Complainant and they at the instigation of other Accused Persons always abused her off and on.
5. That the Complainant bears all such torture with a hope that in future the Accused Persons shall mend their behavior but her all such expectation went in vain.
6. That the husband of the Complainant is a regular drinker and he used to torture the Complainant at the instigation of the other Accused Persons.
7. That when such state of things were going on the Complainant gave birth of two male child and one female child.
8. That the female child is aged about 1 1/2 years and since after her birth the torture upon the Complainant increased a lot.
9. That the Accused Persons demanded a further amount of dowry of Rs.10,000/- from the father of the Complainant. The Complainant informed the matter to her parents but her father replied them that it is not possible for him to fulfill such further demand as he is a poor person.
10. That since thereafter the torture upon the Complainant increased both mentally and physically and during those days she was deprived from two square meals. She was residing with her child outside of the room. Her father used to supply the daily necessities to them as her husband did not look after them. The Complainant had to do all the household work from dawn to late night.
11. That when such state of things were going on the Accused Person No.2 & 3 at the instigation of the Accused Person No.4 & 5, on several occasions asked the

Complainant to left their house as they want to give second marriage of the Accused Person No.1. The Complainant bore all such torture with a hope in near future the Accused Persons would mend their behavior but her such expectations went in vain.

12. That when such state of things were going on, the Accused Persons after assaulting the Complainant mercilessly drove her out from the matrimonial home with her minor female child on 09/08/2018. The Complainant somehow reached her father's house and intimates her parents about the matter.

13. That at present the Complainant being a helpless lady is residing with her father along with her minor daughter and the Accused Persons do not want to keep them at the matrimonial home.

14. That the witnesses No.2, 3 & 4 tried to solve the matter and went to the matrimonial home of the Complainant with a request to keep the Complainant at their house but the Accused Persons abused them and ousted from their house.

15. That the Complainant informed the matter to the O/C Kotshila P.S. requesting him to take legal steps against the Accused Persons but the police did not take any action in the matter up-till now. *The Complainant also informed the matter through registered post on 12.09.2018.*

16. That the Complainant also informed the matter to the S.P. Purulia on 16/08/2018 but up-till now no action has been taken by the police. *on 19.09.2018*

17. That thus the Complainant brought this case for the offences committed by the Accused Persons for which they are liable to be prosecuted.

It is therefore prayed that your honour may graciously be pleased to treat this petition as a Complaint under Section-156(3) of the Cr.P.C. & send the petition to the O/C Kotshila P.S. for investigation & further be pleased to pass necessary order.
