Sub : FIR lodge in connection of the fact happen on 21.12.2018.

I am submitted herewith the fact and assault on the incident occurred at my office and the chamber of the undersigned on 21.12.2018 when a mob of about 25-30 person entered my chamber and did some unwanted and unlawful activity which is stated below,

1. About 25-30 persons entered my chamber at about 11.00 A.M.  
Outside of my chamber many angry persons were moving with sticks in their hand which is visible in the CD,  
Due to hard protection of my security at the gate those person with sticks could not enter in my room.
2. The mob in question asked for issuance of Certificate of Tatwari Gram Panchayat Pradhan in their favour and sitting arrangement of SahaSavapati in Sabhapati 's Chamber.  
This should be kept in knowledge that the Post of Pradhan of Tatwari Gram Panchayat is sub-judge under the Hon'ble High Court so the certificate of Pradhan of Tatwari Gram Panchayat cannot be issued at this stage. The sitting arrangement of Saha-Savapati has been made in accordance with the discussion with the Savapati , of Jhalda-II Panchayat Samiti.
3. In between the conversation, a person named Chepu Turi wearing in saffron turban on his head suddenly raised from his chair abusing badly and directly attack Mukesh Bhagat B.D.M.O Jhalda-II Dev, Block from his behind who was sitting near him but he was seriously saved and rescued from the hand of that attacking person by other person sitting near him at the chamber of the undersigned. I was also protest the situation and told the person that you have right to ask me the question- but you have no right to assault any of my staff. This Fact is captured in the C.C. Camera and the fact is placed in CD and is clearly visible.
4. Again after 15-20 minutes of discussion one man named Luxman Kumar again raised from his seat and all of a sudden directly attacked me and physically assault me by holding my Collar of my shirt and a second person named Hariram Kumar from the behind of that first man (the man who hold my Collar) caught my right hand and tried to pull me from my chair. They are simultaneously abusing me roughly. I was saved by my security. The fact was seen in C.D as captured by the C.C Camera.
5. The effect of this unlawful deed created by those very persons crippled the daily work of my Office, its effect seen not only in the urgent work of the forth coming Election but also hampered the public service of that day. They also made stop the service provided to common people from this Office on that day which is totally illegal and unlawful.
6. These persons created panic atmosphere for which some of my officers and staff were forced to escape from their rooms to save their life. They created the situation so troublesome that I cannot but to bring the situation under control I asked my security to inform the situation to the Officer -in-Charge Police Kotshila so that the Law and Order situation can come under control. The Officer -in-Charge of Police Kotshila Police Station came with his forces and control the situation.

Under these circumstances immediate action must be taken against the accused persons named as 1. Lakshman Kumar, S/O Bhutnath Kumar Vill+PO-Bamnia, 2. Harihar Kumar, 3. Dilip Kumar, Vill+PO-Bamnia directly assault me by one held my Collar and other caught my hand and tried to pull me from my chair as CC camera captured the Snap. 4. Champa Turi, Vill-Tatwara, Turi Para physically assault Mukesh Bhagat B.D.M.O. from behind. 5. Meenakshi Gupte, S/O Jagannath Gupte, Vill+PO-Pandua. 5. Arbinda Kumar, S/O Rohini Ranjan Kumar, Vill+PO-Krechhatu. Both Sl. No. 04 and 05 were inspiring those persons for attacking in my chamber.

All the facts which happen inside my chamber is enclosed herewith as documentary evidences in a CD and the still Photo copies of the concerned person are also enclosed.

The names are collected locally from my end. You are requested to check the name with the photo of the persons (enclosed) from your machinery and if any correction needed, please inform me immediately as I apprehend whether the name of the accused person as per the photograph enclosed herewith is genuine or not. You are requested to look into the matter & also lodge an FIR against the mention persons.
