The above named complainant has to state as follows:-

1) That the complainant and the accused persons are permanent inhabitants of village Khatanga within the District, Purulia and within the jurisdiction of this court.

2) That the complainant is a Panch class under the name of land Kanovanjan Boris, and who has been occupying the bearing P.S. Plot No. 545 in house Khatanga by growing a paddy crop there in for more than 15 years and in the year the complainant also transplanted paddy seedlings on the afore said land which is grown well.

3) That this year at the time of preparation of map on the afore said plot being No. 545 of house Khatanga the above name accused along with some agricultural laborers dispossessed him from the said plot then and thereupon he brought the matter to the local P.S. and also filed a suit No. 3/18 O/S.-144 of Cr.P.C. against the accused person and after hearing the P.S. Magistrate passed an order directing the opposite party i.e. the accused person to file a case why he shall not be restrained from occupying the land i.e. P.S. Plot No. 545 of house Khatanga.

4) That on 26/7/18 the accused person filed a case and after hearing both sides the P.S. Magistrate passed an order O/S. 144 of Cr.P.C. and restrained the accused party i.e. the accused person for two months.

5) That on 17/9/18 at about 7 A.M. the accused persons along with some unknown persons went to the case land and destroy the paddy of a portion of the case land having heard the information the complainant along with her son Ajoy and nephew Ramosh have been to the case land and prevent the illegal acts of the accused person but they say on head cum they threatened the complainant and her associates with dire consequences.

6) That immediately after the incident the complainant informed the matter of disobedience of the order passed by the M. Magistrate but the concerned P.S. did not agree to accept the complaint. There after the complainant send the complain through register post to the G.O. Kottahia Police Station on 19.9.18 but no action has been taken from their side as the complainant informed the matter to the P.S. Kottahia on 27/9/18 but no action has yet been taken as much as the complainant is filing this petition before your honour Court.

7) That the matter is very serious in nature hence police investigation is required.

For the circumstance it is prayed that your honour may be pleased to send this petition of complaint to the officer in charge of Kottahia
