Respected Sir,

In producing herewith one accused Dhiren Mukato (50 Yrs 5'0) Bhola Nath Mihato, of vill Haukasa, P.S. Kotshila Dist. Purulia with seized article 40 liters (approx) illicit spirit, containing in 02 (two) plastic Jars and 01 (One) plastic muri which is kept in Tea Stall, at village Haukasa. Out of which 375 ml taken out from the mother sample as sample which has been seized under proper seizure list.

I beg to submit that today (03.12.18) in between 19.05 hrs and 20.05 hrs on getting a secret source information against unlawful selling of spirit at Haukasa village under Kotshila P.S. I held raid in the Tea Stall of above noted person at Haukasa Village. On searching I found alcoholic smell came out from the 02 (two) plastic Jarcan. On demand he failed to produce any valid documentary authority to the selling of illicit spirit. So I seized 40 liters (approx) illicit spirit, containing in 02 (two) plastic Jarcan and 01 (One) plastic muri and out of which 375 ml taken out from the mother sample as sample which has been seized under proper seizure list and also properly labeled in presence of accused person & other witnesses, which is enclosed here with. I arrested him 19.15 hrs and during arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee. On interrogation he confessed that he running a business of selling illicit spirit in his Tea Stall. He purchased the same from other side for run his business.

The above noted arrested accused Dhiren Mukato (50) Bhola Nath Mihato of vill Haukasa, P.S. Kotshila Dist. Purulia committed offence u/s 18 (1) B.I. Act. For possession of intoxicating not obtained from a licensed vendor and in contravention.

It may note here that during raid C/631 Tulshidas Setpati, C/427 Tapu Kr. Saha, with accompanying me.

Under the fact and circumstance I therefore pray a case u/s 46A (c) B.I. Act. 1909 may kindly be started against Dhiren Mukato (50) Bhola Nath Mihato, of vill Haukasa, P.S. Kotshila Dist. Purulia.
