1. SI Anil Masrani / O/C Kotshila. I do hereby lodge the complaint against Amar Kumar (Male/ 22 Years), S/O- Saajit @ Raghupati Kumar of Vill- Chokya (Mankuli), PO- Chokya, PS- Kotshila, Dist-Purulia to the effect that on 16.12.18 at 12:25 hrs. received a credible source information from my source that one Amar Kumar (S/O- Saajit Kumar of Vill- Chokya, PO- Chokya, PS- Kotshila, Dist-Purulia has been engaged in theft and business of stolen motor cycle and at present he accumulated same stolen motor cycle in his house at Village Chokya, PS- Kotshila, Dist-Purulia. This report Kotshila PS, GD# No-588, Dated- 16.12.18. To track out the source information, myself along with officer & force namely Dy ACP Pradip Kr. Bhattacharjee (D) C/1391 Jayanti Kr. Panda (D) C/12/ Tapas Kr. Saha vide Kotshila PS CC No-4250/18, Dtd: 16.12.18. I held raid in the house of Amar Kumar, S/O- Saajit Kumar of Vill- Chokya, PO- Chokya, PS- Kotshila, Dist-Purulia. On searching we found two (2) Motor Cycles and asked him to show the relevant papers in respect of that stolen cycles, but he failed to produced any valid documents in respect of those motor cycles. During interrogation he confessed that he habitually deal with theft motor cycle and running business of stolen motor cycles in a clandestine manner since last 2-3 years & it is clear that he has procure those M/C by means of theft or any fraudulent means & tried to keep those stolen M/C in concealment. I seized and labelled the following Motor Cycle through proper seizure list in presence of available witnesses:-

1. HERO HONDA CD- BELLE (Red Colour), Engine No- HAHK7974112, Chassis No-MB1HAHNA9E22406, without Reg. Number plate.
2. HERO HONDA SPLENDER PLUS (Black Colour), Engine No- HAH0VAHBA40, Chassis No- MB1HAHQJAH73934, without Reg. Number plate.

Arrested Amar Kumar (Male/ 22 Years), S/O- Saajit @ Raghupati Kumar of Vill- Chokya (Mankuli), PO- Chokya, PS- Kotshila, Dist-Purulia after informing the ground of arrest and informed his family members and issued memo of arrest.

On return to PS I registered the case as Summary U/5-329/11/113/41, HC against arrested Amar Kumar (Male/ 22 Years), S/O- Saajit @ Raghupati Kumar of Vill- Chokya (Mankuli), PO- Chokya, PS- Kotshila, Dist-Purulia and endorsed the case to SI Banaloke Bhattacharjee for investigation and handed over all connective papers in r/w this case as Arrest Memo, Seizure List etc. along with seized articles.
