Amit Kumar, O/C Kotshila P.S. do hereby lodge the complaint against Amar Kumar (Male/ 22 Years), S/O- Basit or Raghupati Kumar of Vill- Chokya (Mankuli), P.O- Chokya, P.S- Kotshila, Dist-Purnia to the effect that on 16.12.18 at 12:25 hrs received a credible source information from my source that one Amar Kumar (O/C) Banj- Kumar of Vill- Chokya, P.O- Chokya, P.S- Kotshila, Dist-Purnia has been engaged in theft and robbery in his house at village Chokya, P.S- Kotshila, Dist-Purnia. This report Kotshila P.S. G.O.M. Sk- 588, Date- 16.12.18 To track out the source information myself along with officer & force namely I.A.S. Pradip Sir, Bhattacharjee H.C/1391 Jayanta Kr. Panda H.C/1427 Tapas Kr. Fahis vide Comilla P.S.C. No-1390/18 Dtd- 16.12.18 I held raid in the house of Amar Kumar (O/C) Banj- Kumar of Vill- Chokya, P.O- Chokya, P.S- Kotshila, Dist-Purnia. On searching we found two (2) Motor Cycles and asked him to show the relevant papers in respect of that Motor cycles, but he failed to produce any valid documents in respect of those motor cycles. During interrogation he confessed that he habitually deal with theft motor cycles and during last 2 years he is committing crimes of stolen motor cycles in a clandestine manner since last 2 years & it is clear that he has procure those M/C by means of theft or any fraudulent means & tried to keep those stolen M/C for remuneration. I seized and labelled the following Motor Cycle through proper seizure list in presence of available witness:

1. HERO HONDA CD- DELUXE (Red Colour), Engine No. HAIKAY/1129, chassis No. HAIKAY/1129, without Reg. Number plate.
2. HERO HONDA SPLENDOR PLUG (Black Colour), Engine No. HAIHAY/1141, chassis No. HAIHAY/1141, without Reg. Number plate.

Interested Amar Kumar (Male/ 22 Years), S/O- Basit or Raghupati Kumar of Vill- Chokya (Mankuli), P.O- Chokya, P.S- Kotshila, Dist-Purnia after informing the ground of arrest and informed his family members and issued memo of arrest.

On which by I.S. I registered the case as Summa U/5-389/11/12/41, H.C. against accused Amar Kumar (Male/ 22 Years), S/O- Basit or Raghupati Kumar of Vill- Chokya (Mankuli), P.O- Chokya, P.S- Kotshila, Dist-Purnia and endorsed the case to S.I. Bandilal Patel H.C. O/C Kotshila P.S. Dist-Purnia and handed over all corrective papers in c/w this case on behalf for investigation and handed over all seized articles.
