Sub-Prayer for starting a specific case against name: Pabitra Hembram(48),s/o-Lt Rameswar Hembram of Sukhapata, PS-Manbazar, Dist-Purulia

Sir,

In proceeding herewith one accused person namey Pabitra Hembram(48),s/o-Lt Rameswar Hembram of Sukhapata, PS-Manbazar, Dist-Purulia under arrest and the following seized articles under seizure list enclosed herewith:

- 1) Sixteen (16) sealed plastic bottles (CS) containing 75ml each and labelled with DILSRHUSH.
- 2) Cash Rs-135/- (One hundred & thirty five only).
- 3) One yellow nylon bag.
- 4) One white big polythin chat

I ASI Sudhir Tudu of Manbazar PS do hereby lodge this complaint regarding that today (30.11.18) at 15:35 hrs during my spl evening mobile duty Kachudora village received a source information over telephone that the above noted accused person has been selling CS liquor illegally and clandestinely in front of residential house at Sukhapata village under Manbazar PS. On receiving the reliable source information communicated with O/C Manbazar PS over telephone and as per his instruction I along with C/1211 Charan Hembram, NVF/566-Tapas Mahato of Manbazar PS rushed to the spot to work out the information. On arrival to the spot at 18.55 I apprehended the above noted person after a strong attempt and one customer seeing Police party managed to escape. On close interrogation that apprehended person had disclosed his name address as noted above. I asked him to produce any valid paper in support of selling that liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly at 19.05 hrs I seized all the items noted above after preparing proper seizure and labelled the seized articles duly signed by the accompanying party in the seizure list and the label. One bottle 37.5 ml liquor has been kept as sample taken from the seizure as sample which was also duly labelled and also took signature of the accompanying witness on seizure list and label. After this I arrested that accused person namey Pab. Hembram(48),s/o-Lt Rameswar Hembram of Sukhapata, PS-Manbazar, Dist-Purulia after preparing proper memo of arrest at 19.35.

Under the above facts & circumstances I pray before your honour that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
