Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity Act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Suntosh Bauri S/O Bujai Bauri of Village- Bhurabole, P.O- Pirorgoraria, P.S. Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 14.12.18 at about 03:40 P.M. Sri Swarup Mondal, Station Manager, Manbazar Customer Care Centre, WBSFDC along with,

- 1) Tiaur Rahaman Mondal, S.I.(E), SLP unit Farakia Region WBSFDC
 - 2) Ramendra Narayan, S.O. SLP unit, Farakia Region WBSFDC

 - 4) Benod Gorain, Hg.TSI, Manbazar C.C.C. WBSFDC
- entered the premises of Sambhu Bauri S/O _____ of Village- Bhurabole, P.O- Pirorgoraria, P.S. Manbazar, Dist - Purulia and Inspected his/her premises and found that he was enjoying electricity unlawfully by direct hooking from WSEDC's LT OH line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 2) one no. ceiling Fan (60 watt)

out of which we seized the following -
