Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Suntesh Bauri S/O Bujai Bauri of Village- Bhurasole, P.O. Pirargoria, P.S. Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 14.12.18 at about 03:40 P.M., Sri Swarup Mondal, Station Manager, Manbazar Customer Care Centre, WBSEDC, along with,

- 1) Jiaur Rahaman Mondal, D.I.E, SLP unit Purulia Region WBSEDC
- 2) Ramandra Narayan, SO SLP unit, Purulia Region WBSEDC

entered the premises of Santes Bauri S/O- of Village- Bhurasole, P.O. Pirargoria, P.S. Manbazar, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity unauthorizedly by direct hooking from WBSEDC's LT OH line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) Two nos 100 watt bulb
- 2) one no ceiling fan (60 watt)

out of which we seized the following -

- 2) Written (13) ft' PVC wire (Wagal) along with hooking device

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 03:50 P.M on dated 14.12.18. The accused person has committed an offence U/S 135(1)(a) of the Electricity Act 2003 (Amendment) Act-2007.
