Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. Person namely Pankaj Kumar Choudhary (29) S/O- Bihari Choudhary of Parbelia Amdhowra, PS-Neturia, District- Purulia with seizure of (1) 09 pcs. Sealed bottles of Captain Country Sprit containing 600 ml each (2) 06 pcs. Sealed bottles of Dil Se Country Sprit containing 600 ml each and (3) 20 pcs. Sealed bottles of Dil Khush Country Sprit containing 375 ml each which were seized under proper seizure list.

I beg to submit that today (30.11.18) in between 18.45 hrs to 19.55 hrs. a raid was conducted at Parbelia Colliery near Jaksala in the hotel of Pankaj Kumar Choudhary (29) S/O- Bihari Choudhary of Parbelia Amdhowra, PS-Neturia, District- Purulia on acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling liquor which were kept in his hotel, on demand Pankaj Kumar Choudhary failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents . As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also (1) 09 pcs. Sealed bottles of Captain Country Sprit containing 600 ml each (2) 06 pcs. Sealed bottles of Dil Se Country Sprit containing 600 ml each and (3) 20 pcs. Sealed bottles of Dil Khush Country Sprit containing 375 ml each which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Pankaj Kumar Choudhary (29) S/O- Bihari Choudhary of Parbelia Amdhowra, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1. C/1303 Biswanath Majhi and 2. JC/702 Pratap Narayan Das both of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Pankaj Kumar Choudhary (29) S/O- Bihari Choudhary of Parbelia Amdhowra, PS-Neturia, District- Purulia under proper section of law.
