Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. Person namely Baban Bhagat (36) S/O- Murarilal Bhagat of Siridhowra, PS-Neturia, District- Purulia with seizure of (1) 08 pcs. Sealed bottles of Captain Country Sprit containing 600 ml each (2) 04 pcs. Sealed bottles of Dil Se Country Sprit containing 600 ml each and (3) 25 pcs. Sealed bottles of Dil Khush Country Sprit containing 375 ml each which were seized under proper seizure list.

I beg to submit that today (30.11.18) in between 18.55 hrs to 20.05 hrs. a raid was conducted at Parbelia Colliery near Jaksala in the hotel of Baban Bhagat (36) S/O- Murarilal Bhagat of Siridhowra, PS-Neturia, District- Purulia on acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling liquor which were kept in his hotel, on demand Baban Bhagat failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents . As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also (1) 08 pcs. Sealed bottles of Captain Country Sprit containing 600 ml each (2) 04 pcs. Sealed bottles of Dil Se Country Sprit containing 600 ml each and (3) 25 pcs. Sealed bottles of Dil Khush Country Sprit containing 375 ml each which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Baban Bhagat (36) S/O- Murarilal Bhagat of Siridhowra, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1. C/78 Utpal Sarkar and 2. C/1260 Santosh Soren both of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Baban Bhagat (36) S/O- Murarilal Bhagat of Siridhowra, PS-Neturia, District- Purulia under proper section of law.
