I Sri Bibhan Baul, s/o Dilip Kr. Baul aged 29 yrs. Station Manager Saitore ccc, WBSEDCL do hereby lodge Complaint against Fomibhram Mondal (Present user) s/o - Lt Fomun Mondal of u/u - Raibandi

On today (06-12-2018) at about 14:20 hrs myself along with ① Sri Kamal Sarma, LM ② Sri Gouram Kr Pandey, Hg TSH of Saitore ccc had been in the home of Sri Fomibhram Mondal (Present user) for impaction. Prior impaction a notice was served upon Sri Mondal

A through impaction was conducted by me assisted by the technical staffs and found Sri Fomibhram Mondal Connected one a wire after removing the terminal cover of the energy meter with incoming phase from pole side and other end the wire has been connected to the main switch thereby using electricity un-authorisally and without reflecting the energy consumption on the meter. From the arrangement he was using the electrical equip. ment viz:- ① Electric Bulb - 04 nos (100 watt each) ② Electric Fan - 02 nos (80w each) ③ Electric CFL Lamp - 02 nos (20w each). Total load found 0.56 kw. This is a clear theft of electricity and Sri Fomibhram Mondal is liable for Prosecution under Section 135(1)(b) of the IE Act 2003 duly amended on 2007. The total works of operandi was photographed and the service connection is disconnected from pole side.
