In producing here with the arrested accused Sk Sahabuddin (30yrs)S/O- Lt Sk Sir. Nazir of Vill- Baishyakuli, PS- Para, Dist- Purulia A/P- Vill- Sankra B Kasaikuli, PS-Para, Dist- Purulia and one seized improvised country made firearm having length 10.5 inch approx from butt to barrel, 5.5 inch barrel, having firing pin and trigger along with two (01) round ammunition. Today on 09.12.18 at 21:05 hrs when I along with force were performing NAKA duty at Darda Morh bordering to Jharkhand received a credible source information that one person is coming from Jharkhand side towards Dubra possessing a gun with him. I informed the matter to O/C Para PS. I also briefed the information to my accompanying force. Sometimes later at 21:45 hrs found that one person is coming from Jharkhand side. When the person came near to Darda morh seeing the Police party he started to run to hide himself in the dark of night. We chased him and after a hot chase we able to intercept him in front of Darda High School. On search found that he possessed one improvised country made firearm at left side of his waist and in right side pocket of his pant there is 01(One) rd ammunition. On asked he disclosed his identity as Sk Sahabuddin (30yrs) S/O- Lt Sk Nazir of Vill- Baishyakuli, PS- Para, Dist- Purulia A/P- Vill- Sankra 'B' Kasaikuli, PS-Para, Dist- Purulia and on asked he could not able to produce any license or valid document in respect of possessing or carrying of that improvised fire arms. Finding no other alternative I arrested him after informing him the ground of arrest and after observing all legal formalities and also seized the improvised country made firearm along with 01(One) rd ammunition from the exclusive possession of the arrested accused person Sk Sahabuddin under proper seizure list in presence of witnesses duly signed by them. As it is dark of night no public witness was available.

Under the above circumstances I pray before you for starting a case under proper section of law against accused Sk Sahabuddin (30yrs)S/O- Lt Sk Nazir of Vill-Baishyakuli, PS- Para, Dist- Purulia A/P- Vill- Sankra B Kasaikuli, PS- Para, Dist-Purulia for possessing and carrying of improvised country made fire arms and arrange for its investigation.
