On dated 27-12-2018 at about 2:45 pm I, Sri Santanu Sinha, Station Manager Anara CCC Customer Care Centre, WBSEDCL along with,

Entered the premises of SAKTAR ANSARY, S.O- LT. KAYEM ANSARY of Village- LIPANIA , P.O- LIPANIA , P.S- PARA , Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by direct hooking from LT wire by PVC wire (approx - 25m).

Supply i.e. U/S 135 was detected.
