I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **Pranab Kumar Char, S/O-Shakti Pada Char, of Village-Udaypur, P.S.-PARA, Dist-Purulia**, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.


On 07.12.2018 at about 1.10 PM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with Laxman Mahato HG.GR.Lines Men of Dubra Para CCC, Patit Kora, Hr. TSH of Dubra Para CCC, Sanjay Prasad Sr.TSH,Bhakti Pada Mahato,TSH of Dubra Para CCC and other staffs of Dubra Para CCC, WBSEDCL inspected the premises of **Pranab Kumar Char S/O- Shakti Pada Char of Village-Patharkuchi(Para),P.S.-Para, Dist-Purulia WBSEDCL**. During inspection it was found that the said **Pranab Kumar Char** was enjoying electricity unauthorziedly by direct hooking of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 01no led bulb 9watt,03 nos 205ltrs deep fridge 555watts, and 01no.525ltrs Deep Fridge 370watts, approx load 0.934 KW for Commercial purpose, which is an offence u/s. 135 (1)(a) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 1:30 PM.

As such **Pranab Kumar Char, S/O- Shakti Pada Char of Village+P.O.- Udaypur P.S.- Para, Dist- Purulia** has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
