

Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that Bijay Roy S/O-Late Shymapada Roy of Village-Patharkuchi(Para), P.S.-PARA, Dist-Purulia, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a)of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 07.12.2018 at about 09:20AM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with Laxman Mahato HG.GR.Lines Men of Dubra Para CCC, Patit Kora Hr. TSH of Dubra Para CCC, Sanjay Prasad Sr.TSH of Dubra Para CCC and other staffs of Dubra Para CCC, WBSEDCL inspected the premises of Bijay Roy S/O- Late Shymapada Roy of Village-Patharkuchi(Para), P.S.-Para, Dist-Purulia WBSEDCL. During inspection it was found that the said Bijay Roy was enjoying electricity unauthorizedly by direct hooking of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 02 nos CFL bulb 09 Watt and 01 no Stand fan 110Watt, approx load 0.128KW for domestic purpose, which is an offence u/s. 135 (1)(a) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 9:30 am. As such Bijay Roy, S/O- Late Shymapada Roy of Village- Patharkuchi(Para), P.S.- Para, Dist-Purulia has committed an offence of theft of electricity under section 135 (1)(a)of Electricity Act. 2003 read with amendment of Electricity Act. 2007.So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
