I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Mahasin Ansary S/O- Lt Samsuddin Ansary of Village- Duarimahal, P.O- Lipania, P.S- Para, Dist-PURULIA has committed theft of Electricity U/S-135 of the Electricity (Amendment) Act-2007. On dated 21.12.2018 at about 12.10pm I, Sri Santanu Sinha, Station Manager Anara CCC Customer Care Centre, WBSEDCL along with,

Entered the premises of Mahasin Ansary, S.O- Lt Samsuddin Ansary of Village- Duarimahal, P.O- Lipania, P.S- Para, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by direct tapping from Incoming service cable

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- (i) 2 nos Led Bulb - 2x2 = 40 watt
 - (ii) 1 nos Bulb - 1x100 = 100 watt
 - (iii) 3 nos Fan - 3x80 = 240 watt
 - (iv) 1 nos Bridge - 180 watt
 - (v) 1 nos TV - 120 watt
 - (vi) 1 nos Tube - 40 watt
- Out of which we seized the following:
- (a) Tapping service cable approx 2 meter.

The seizure list are prepared at the site and the accused person refuse to signed in the seizer list .

The inspection team left the above premises at about 12.20 pm on dated 21.12.2018 .The accused person has committed an offence U/S-135(i) (b) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per Rule.
