I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Najamuddin Ansary S/O- Kutubuddin Ansary of Village- Durgamahal P.O- Lipania P.S- Para Dist-PURULIA has committed theft of Electricity U/S-135 of the Electricity (Amendment) Act-2007.

On dated 21-12-2018 at about 12.25pm I, Sri Santanu Sinha, Station Manager Anara CCC Customer Care Centre, WBSEDCL along with,

Entered the premises of Najamuddin Ansary S.O- Kutubuddin Ansary of Village-Durgamahal P.O- Lipania P.S- Para Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by direct tapping from incoming side of service cable.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- ① CFL - 5 NOS (5x20 watt)
- ② Tube - 2 NOS (2x40 watt)
- ③ stand fan - 2 (120x2 watt)
- ④ ceiling fan - 3 (3x80 watt)
- ⑤ TV - 1 NOS (120 watt)

Out of which we seized the following:

- ① Energy meter with tapping service cable
