I do hereby lodge a complaint empowered by enabling the Electricity act, 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri JABBAR ANSARY (Present user) S/O- LI IDRISH ANSARY of Village- BARAIRGA, P.O- LIPANIA, P.S- PARA, Dist-PURULIA has committed theft of Electricity U/S-135 of the Electricity (Amendment) Act-2007.

On dated 21.12.2018 at about 12.55pm, Sri Santanu Sinha, Station Manager Anara CCC Customer Care Centre, WBSEDCL along with,

Entered the premises of JABBAR ANSARY (Present user), S.O- LI IDRISH ANSARY of Village- BARAIRGA, P.O- LIPANIA, P.S- PARA, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by means of direct tapping from incoming side of service cable.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- ① CFL → 5 Nos. (20W×5=100W) ③ TV → 1 No. (120W)
- ② Fan → 3 Nos. (80W×3=240W) ④ Fridge → 1 No. (180W)

Out of which we seized the following:

- ① Electricity meter with tapping service cable.

The seizure list are prepared at the site and the accused person refuse to signed in the seizer list.

The inspection team left the above premises at about 01.10 pm on dated 21.12.2018. The accused person has committed an offence U/S-135(i)...(b)... of the Electricity (Amendment) Act-2007.
