In producing herewith the arrested accused persons namely 1. Suresh Kumar Dey (22 yrs) S/O- Manu Dey of Vill- Modi Karkatta, P.O- Chandra, Bongariya OP under Sialjuri PS, Dist- Bokaro (Jharkhand) 2. Dilip Tiwari (28 yrs) S/O- Lt Dasarath Tiwari of Vill- Saharjuri, P.O+ P.S -Chandankiyari, Dist- Bokaro (Jharkhand) 3. Manik Dhibar (27) yrs S/O- Saligram Dhibar of Vill+ P.O- Chandra, Bongariya OP under Sialjuri PS, Dist-Bokaro (Jharkhand) and seized articles 1. One black color cotton bag 2. Cannabis (Ganja) 14 kg 800 gm Marked as Exhibit "A", 3. One black color cotton bag 4. Cannabis (Ganja) 11 kg 800 gm Marked as Exhibit "B", 5. 100 gm Cannabis (Ganja) in a light green envelop, Marked as Exhibit "A-1", 6. 100 gm Cannabis (Ganja) in a light green envelop, Marked as Exhibit "A-2", 7. 100 gm Cannabis (Ganja) in a light green envelop, Marked as Exhibit "A-3", 8. 100 gm Cannabis (Ganja) in a light green envelop, Marked as Exhibit "B-1", 9. 100 gm Cannabis (Ganja) in a light green envelop, Marked as Exhibit "B-2", 10. 100 gm Cannabis (Ganja) in a light green envelop, Marked as Exhibit "B-3", 11. One Black colour Honda shine 125 CC motor Cycle bearing Regn No JH 09Y/9683, Engine No- JC36E73782535, Chasis ME4JC36NLE7150712 12. weighing instruments along with 2 kg, 1 kg, 500 g, 200g, 100g weight, I, SI Biswajit Mondal, O/C Para Police Station do hereby lodged a suo-motu complaint against arrested accused person namely 1. Suresh Kumar Dey (22 yrs) S/O- Manu Dey of Vill- Modi Karkatta, P.O- Chandra, Bongariya OP under Sialjuri PS, Dist- Bokaro (Jharkhand) 2. Dilip Tiwari (28 yrs) S/O- Lt Dasarath Tiwari of Vill- Saharjuri, P.O+ P.S - Chandankiyari, Dist- Bokaro (Jharkhand) 3. Manik Dhibar (27) yrs S/O- Saligram Dhibar of Vill+ P.O- Chandra, Bongariya OP under Sialjuri PS, Dist- Bokaro (Jharkhand) to the effect that today i.e on 23.12.18 at 12:25 hrs. I got an information that the above noted accused persons were coming from Jharkhand side to Raghunathpur side riding on a motorcycle through Raghunathpur Chandankiyari Road with some contraband articles in two bags. The information was duly entered in PS GD Book vide Para PS GDE No- 857 Dt- 23.12.18.

Accordingly myself along with ASI Atanu Das, ASI Purnendu Banerjee, C/30 Nimai Ch Ganguli, C/976 Shibaprasad Mukherjee, C/793 Prasanta Patra, C/336 Kartick Ch Roy left PS with Govt. vehicle bearing No- WB24K/7871 at 12:35 hrs vide Para PS CC No-2761 dated 23.12.18 and Para PS GDE No-858 dated 23.12.18 to work out the information vide Para PS PS GDE No-857 Dtd-23.12.18.

At 12:45 hrs. we arrived near Dubra Smasan Kali Mandir on Raghunathpur Chandankiyari road and started waiting for the said persons standing at the south side of the said Mandir. At 13:15 hrs. we noticed that 03(Three) persons were coming from Jharkhand side riding on a motor cycle with 02(Two) black colour bags. We gave signal to stop the motorcycle but the rider willfully ignored the signal and tried to flee away along with motorcycle. We Chased them and after a hot chase we managed to detain them at Rukni Morh . Being asked they disclosed their identity as 1. Suresh Kumar Dey (22 yrs) S/O- Manu Dey of Vill- Modi Karkatta, P.O- Chandra, Bongariya OP under Sialjuri PS, Dist- Bokaro (Jharkhand) 2. Dilip Tiwari (28 yrs) S/O- Lt Dasarath Tiwari of Vill-Saharjuri, P.O+ P.S - Chandankiyari, Dist- Bokaro (Jharkhand) 3. Manik Dhibar (27) yrs S/O-Saligram Dhibar of Vill+ P.O- Chandra, Bongariya OP under Sialjuri PS, Dist- Bokaro (Jharkhand). On physical verification it is found that there are 02(Two) big size cotton bags one is in the possession of Suresh Kumar Dey and another is in the possession of Dilip Tiwari. From the odor of the contained of the bags it appears to be cannabis.

I send requisition to BDO, Para with a request to remain present as executive magistrate at P.O. during the search and also send another requisition to CI, Kashipur requesting him to be present during the search. Accordingly I detained the persons and motorcycle with O2(two) bags and started waiting for the arrival of Executive Magistrate and C.I. Kashipur. By this time two persons namely (1) Subhas Paramanik S/O- Badal Paramanik of Vill- Kashiberiya, PS- Para, Dist-Purulia (2) Baidyanath Bouri S/O- Sukdev Bouri of Vill- Dheria, PS- Para, Dist-Purulia who were present there at that time I informed the matter to them and requested them to be present there as witness during search. I then asked Subhas Paramanik S/O- Badal Paramanik of Vill- Kashiberiya, PS- Para, Dist- Purulia in writing whether he has any weighing machine or balance. If he has whether he is ready to weigh the Cannabis (Ganja). He replied in writing and brought the weighing instruments from his home at 14:15 hrs.

Officer-in-charge Officer-in-charge Para Police Station At 14.35 hrs. Shri Aniruddha Banerjee, WBCS (Exe), Block Development Officer, Para Development Block and Shri Rajat Kanti Pal, CI Kashipur arrived at the P.O. i.e. at Rukni Morh on Raghunathpur Chandankiyari Road. Then I asked the detained persons in writing to search our selves. Accordingly he searched all police persons thoroughly but found nothing objectionable. He declared this in writing.

After that we asked them that we would search them and their bags. I asked them in writing whether they wanted the search to be conducted in presence of Executive Magistrate and Gazetted officer. They replied affirmatively and I informed the matter to the Executive Magistrate & CI Kashipur.

Then I started searching those 03(Three) persons and their bags. During search I found that the bags which were one was in the possession of Suresh Kumar Dey and another was in the possession of Dilip Tiwari were packed with Cannabis (Ganja).

Then Subhas Paramanik S/O- Badal Paramanik of Vill- Kashiberiya, PS- Para, Dist- Purulia weighed the Cannabis (Ganja). After weighing it is found that 01(One) bag contained with 15 Kg 100 gm Cannabis (Ganja) and another bag contained with 12 Kg 100 gm Cannabis (Ganja)

Then I took three samples from 01(One) bag, each contained with 100 gms Cannabis (Ganja) and three samples from another bag each contained with 100 gms Cannabis (Ganja) as sample for taking follow up action. I seized, sealed, labeled the bags containing cannabis (Ganja) and 06(Six) sample packets and the motor cycle under proper seizure list duly signed by the witnesses.

On demand the accused persons could not produce any documents for the said Cannabis (Ganja). I arrested them. I briefed them the ground for which they were arrested. I also asked them whether they were willing to inform any one regarding his arrest. I issued Memo of Arrest and Inspection memo. The entire search seizure and arrest was done in presence of Shri Aniruddha Banerjee, WBCS (Exe), Block Development Officer, Para Development Block and Shri Rajat Kanti Pal, CI Kashipur.

Now after on return to PS along with the seized articles and arrested accused persons namely Suresh Kumar Dey (22 yrs) S/O- Manu Dey of Vill- Modi Karkatta, P.O- Chandra, Bongariya OP under Sialjuri PS, Dist- Bokaro (Jharkhand) 2. Dilip Tiwari (28 yrs) S/O- Lt Dasarath Tiwari of Vill- Saharjuri, P.O+ P.S - Chandankiyari, Dist- Bokaro (Jharkhand) 3. Manik Dhibar (27) yrs S/O- Saligram Dhibar of Vill+ P.O- Chandra, Bongariya OP under Sialjuri PS, Dist- Bokaro (Jharkhand), started Para PS Case No-153/18 dated 23.12.18 U/S 20(b)(i)/29 of the NDPS Act, 1985 and endorsed the case to SI Sibsankar Pal for its investigation.
